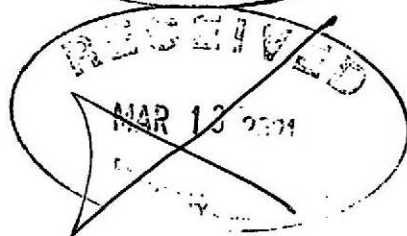
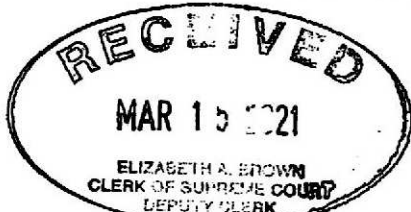
On January 15, 2021, Transcript Video Services received a request for an estimate of transcripts from Daniel Mann for the following proceedings:
