The Appellants' answer to Question 24 of the Docketing Statement filed December 4, 2020 is incorrect. The District Court order that Appellants' have appealed from is an order remanding the matter back to the administrative Appeals Officer for further proceedings regarding whether Mr. Gill properly reported his occupational disease to his employer, or if the reporting requirement should be excused under NRS 617.346. Thus, not all issues have been finally decided below. This does raise a question of jurisdictional defect and at an appropriate time Respondent will file a motion to dismiss as required by NRAP 14(f).
