Pursuant to the Court's Order of October 13, 2021, Appellant moves the Court to remove Rosie Albisu, John Albisu, and Anchor S-Ranch and Rentals, LLC from the appeal.

John Albisu, husband of Rosie Albisu, died intestate during the litigation at the district court. At the district court, Appellant's trial counsel brought a motion to dismiss the underlying action against John Albisu, which the record indicates was unopposed by Respondent. See Motion for Dismissal of Action Against John Albisu, attached as Exhibit A. However, the district court never ruled on the motion.

Anchor S-Ranch and Rentals, LLC is a revoked Nevada limited liability company, included in the underlying lawsuit by Respondent. See Exhibit B. No motion was made in the district court below to remove Anchor S-Ranch and Rentals, LLC. as a party to the action.

Rosie Albisu, as the wife of John Albisu at the time of his death, was the heir to the property servient to the prescriptive easement imposed by the district court. Prior to the district court's final judgment, Rosie Albisu transferred all right, title, and interest in the subject property to Ty Albisu and Linda Albisu, as joint tenants. Rosie Albisu died after the filing of the Notice of Appeal in this case. Ty Albisu and his brother Joseph Albisu serve as joint executors of the estate of Rosie Albisu.

As the property at issue, servient estate to the prescriptive easement found by the district court, is now solely owned by Ty and Linda Albisu, Appellants ask that John and Rosie Albisu, and Anchor S-Ranch and Rentals, LLC. be removed as parties to this appeal. There are no other issues before this Court beyond the finding of the prescriptive easement, and the district court's failure to join indispensable parties, Linda Albisu and additional Wilkinson parties.
