I ask because if he had hydrocodone in his system, we may be able to deny the claim as it stands right now but if he was under the influence of medication, that medication would have to be the proximate cause of his injury pursuant to NRS616C.230:

NRS 616C.230 Grounds for denial, reduction or suspension of compensation; evidence of and examination for use of alcohol or controlled substance.

- 1. Compensation is not payable pursuant to the provisions of chapters 616A to 616D, inclusive, or chapter 617 of NRS for an injury:
 - (a) Caused by the employee's willful intention to injure himself or herself.
 - (b) Caused by the employee's willful intention to injure another.
- ** (c) Proximately caused by the employee's intoxication. If the employee was intoxicated at the time of his or her injury, intoxication must be presumed to be a proximate cause unless rebutted by evidence to the contrary.
- **(d) Proximately caused by the employee's use of a controlled substance. If the employee had any amount of a controlled substance in his or her system at the time of his or her injury for which the employee did not have a current and

lawful prescription issued in the employee's name or that the employee was not using in accordance with the provisions of chapter 453A of NRS, the controlled

The compensation must be suspended until the injured employee is able to resume treatment, testing or examination for the industrial injury. The insurer may elect to pay for the treatment of the nonindustrial condition or injury.

It comes down to this:

You, as the employer, you reserve the right and you may write him up or terminate him (NV is a right to work state) for bringing a controlled substance into work and possibly (I say possibly because we don't know for sure) taking a controlled substance during working hours.

As far as him ignoring you or ducking you, I will review my incoming faxes/mail to see if I received a current work status note and if it says modified duty, lets get a paper trail going that says you are able to offer a temporary modified duty position to him within restrictions set forth by his authorized treating physician so we are not stuck having to pay this guy benefits to be off of work. As I understand it, anyone being paid temporary total disability benefits (TTD) on a claim raises your premiums. NV regulations do state that if a temporary modified duty position can be offered, employer may do so verbally but must make the offer in writing within 10 working days. The position must be similar with regards to his training and education, the job can't be demeaning, the job must be within 80% of his normal pay and has to be substantially similar in location, pay and job duties.

Additionally, do you recall when we spoke last that I said either someone is coaching him or he's had a claim before? I love it when I'm right! In this case I didn't want to be right though.

I can call you in a bit if you like and we can talk further about it.


