### POINTS AND AUTHORITIES

NRAP 46(e)(3) states that:

a withdrawal of counsel may be effected only by filing a motion in the court. The withdrawing attorney shall serve a copy of he motion on the attorney's client and any adverse party. The motion shall clearly state the reasons for the attorney's withdrawal consistent with SCR 46 and RPC 1.16. A motion that is filed after judgment or final determination as provided in SCR 46 will only be granted if the Supreme Court or Court of Appeals has issued a final decision in the matter and the time for filing a petition for rehearing has expired.

Respondent, Kizzy Burrow elected to change counsel on or about September 29, 2020. On February 18, 2021, Respondent's new counsel, Yvonne Ruiz, Esq. of Marzola & Ruiz Law Group PLLC, filed a Notice of Appearance instead of a substitution of counsel. Respondent's intention, however, was to replace her counsel.

The Standish Law Group, in accordance with the wishes of Respondent, and with the consent of the Marzola & Ruiz Law Group PLLC, seeks to withdraw as co-counsel for Respondent, leaving Yvonne Ruiz, Esq. of Marzola & Ruiz Law Group PLLC in place as Respondent's counsel. The reason for the withdrawal is that Respondent, Kizzy Burrow, no longer wishes the Standish Law Group to represent her in this matter.
