Pursuant to N.R.A.P. 31(e), Ali Shahrokhi "Appellant", notifies the Court of the following supplemental authorities.

1. On December 7, 1993, the Nevada Supreme Court issued its Decision in State ex rel. Stokes v. Second Judicial Dist. Court, 55 Nev. 115.

The Court held that:

"If the affidavit of prejudice is timely filed, the judge is thereby deprived of all discretion in the matter, and it becomes his statutory duty to proceed no further in the action and to assign the case to another judge as provided by law." See, State ex rel. McMahan v. First Judicial Dist. Court, 78 Nev. 314, 371 P.2d 831, 1962 Nev. LEXIS 128 (Nev. 1962)

This relates to question # 12, statement of issues presented for review, Appellant's brief on page ix, asking this Court, May family court judges' issue any orders against a party who has a disqualification motion pending before the chief judge.
