*ORDER DENYING MOTION FOR STAY
AND GRANTING MOTION TO JOIN PETITION*

In this original petition for a writ of mandamus, petitioner seeks a writ directing the district court to vacate its order denying summary judgment based upon the applicable statute of limitations.

Petitioner filed a motion to stay based primarily upon this court's order directing answer. In determining whether to grant a stay pending resolution of a writ petition, this court considers the following factors: (1) whether the object of the petition will be defeated if the stay is denied; (2) whether petitioner will suffer irreparable or serious injury if the stay is denied; (3) whether real parties in interest will suffer irreparable or serious injury if the stay is granted; and (4) whether petitioner is likely to prevail on the merits of the petition. NRAP 8(c); *see also Fritz Hansen A/S v. Eighth Judicial Dist. Court*, 116 Nev. 650, 659, 6 P.3d 982, 987 (2000). Having considered the motion, the opposition thereto, and the reply, this court concludes that petitioner has not demonstrated that these factors militate in favor of a stay at this time. Accordingly, the motion for stay is denied.

Real parties in interest, Dionice S. Juliano, M.D., Conrado Concio, M.D., and Vishal Shah, M.D. filed a notice of non-opposition to the petition for a writ of mandamus and a motion to join the petition. The motion to join the instant petition is granted. The clerk of this court shall modify the caption on the docket for this case to conform with the caption of this order.

It is so ORDERED.
