## **RESPONSE TO DOCKETING STATEMENT**

Appellant's docketing statement contains several objective inaccuracies. First, the trial lasted 18 days, not 16. That is not including the punitive damages hearing, which would make the trial 19 days. This error is material because the Appellants ordered the trial transcripts for each day of trial except the two days where Appellant Parviz Safari testified. Those two days of testimony are highly relevant to the issues on appeal. Second, Appellants' list of issues on appeal includes several summary judgment rulings. However, Appellant did not check "Summary judgment," in section 4 of the docking statement. Appellant also checked "Grant/Denial of NRCP 60(b) relief" in section 4 even though no NRCP 60(b) motion was filed in the district court. These errors are material because Appellant could not articulate what exactly is being appealed when the parties held a meet-and-confer on transcripts. Third, Exhibit 12 to the docketing statement is incomplete, as it only lists the derivative counterclaims on behalf of Meditex, not the individual claims. Respondents asked Appellants to correct these errors in the docketing statement but Appellants did not respond.
