Docket No. 82234, the parties have filed a stipulation to consolidate the appeals. In the stipulation, the parties appear to concede that the orders challenged in Docket Nos. 82094 and 82234 are interlocutory, and that they may be challenged in the context of Docket No. 82294 on appeal from the final judgment. See Consol. Generator-Nev., Inc. v. Cummins Engine Co., 114 Nev. 1304, 1312, 971 P.2d 1251, 1256 (1998). The stipulation to consolidate is disapproved as moot.
