## POINTS AND AUTHORITIES

On May 10, 2021, Appellant Travis Bish filed an opening brief in this matter, which challenges the district court's denial of a petition for extraordinary relief regarding the bail hearing for Mr. Bish by the Sparks Justice Court. On June 8, 2021, Respondent, the State of Nevada, filed both a Motion to Dismiss this appeal, as well as a Motion to Stay Briefing Schedule pending this Court's decision on Respondent's Motion to Dismiss. Mr. Bish did not oppose the Motion to Stay, which was subsequently granted by this Court on June 25, 2021.

Mr. Bish subsequently filed an Opposition to the Motion to Dismiss. The Motion to Dismiss was denied without prejudice on July 13, 2021.

Given the denial of the Motion to Dismiss, Mr. Bish respectfully requests the Court to reinstate briefing in this appeal. Mr. Bish specifically requests the Court to instruct that any Answering Brief be filed within 30 days of the date of any order granting this motion, with a Reply Brief to be filed 30 days thereafter.
