

16 correct to his knowledge and belief.

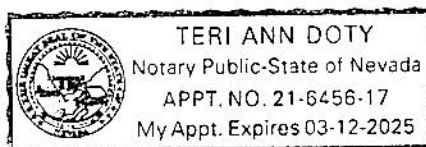
