NOTICE OF DISTRICT COURT'S ORDER DENYING BARRICK GOLD CORPORATION'S MOTION TO DISMISS PLAINTIFF'S THIRD AMENDED COMPLAINT

Petitioner Barrick Gold Corporation ("Barrick Gold") hereby notifies the Court of the district court's Notice of Entry of Order Denying Barrick Gold's Motion to Dismiss Real Party in Interest Bullion Monarch Mining, Inc.'s ("Bullion") Third Amended Complaint ("TAC"). A true and correct copy of the Notice of Entry of Order is attached. The District Court denied Barrick Gold's motion to dismiss Bullion's TAC for reasons consistent with the district court's order denying

Barrick Gold's motion to dismiss Bullion's Second Amended Complaint ("SAC") challenged in Barrick Gold's Writ of Prohibition (the "Petition").

Notice is being provided about the district court's ruling on the TAC as it may impact the Court's decision on Bullion's pending motion to dismiss the Petition and Barrick Gold's pending countermotion for stay pending decision on the Petition. Barrick Gold intends to promptly move to supplement the Petition and related appendix to make clear that Barrick Gold's Petition additionally challenges the district court's denial of Barrick Gold's motion to dismiss Bullion's TAC.
