that a writ of mandamus issue,

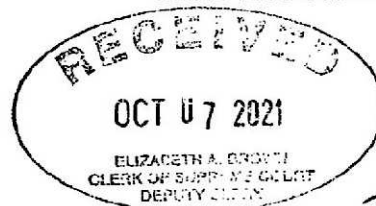
NOW, THEREFORE, you are instructed to vacate the order denying
