COMES NOW, Appellant, ANDRE GRANT SNIPES, and requests this Court order Court Recorder, ANGIE CALVILLO, to prepare the transcript of the January 30, 2020 hearing in this case which was requested in a formal transcript request filed and served on Ms. Calvillo on January 27, 2021.
