Being asked this when I need a blood cord, so one of them better speak
With counsel because The CIA is going to investigate and the report to
The court will be brutal. I remind them once again, one is secure in there
Home....If they choose to communicate or make up stories that I don't
Need to have sex, who wants to communicate to the judge? This is all
Getting reported. Both defendant's are fully aware that any such plots
Will be reported and further request for damages will be demanded.
Any false and misleading lies, as I believe defendant O'Neil is once
Again suffering from delusions, as I will report all of this to my aunt.

6. There better not be any further deep state stuff going on, both
Defendants both know better. The only right they have is to remain
Silent, as this is " deep state" stuff that has to be resolved by my aunt
Who is retired and better cease, because if we find out any Colorado
Stuff is lingering BOTH defendants will be demanded to pay further
Fines. My aunt will be investigating and shutting it down. I am NOT
Permitted to travel out of state because defendant O'Neil has fused so
Many states, my aunt has to be certain that this activity is stopped as it
Is a serious Federal violation. Defendant O'Neil better start acting like an
Adult instead of a mentally impaired child, Her conduct is deplorable and
Everything from Colorado needs to be extinguished, nobody wants to

Travel to London, I have to because both of our defendants have caused
So much trouble fusing together this state stuff. There will be a Federal
Investigation, both defendants are going under investigation for human
Trafficking again, do NOT suggest movement until it is cleared.

Defendant O'Neil has no education, shes a deplorable drug informant
Who better worry about herself until the investigation is over. I will
Never return to the east coast, they conceived a plot to chase me, now
Both defendants can start packing and start moving, they want to harass
Movement they can both start moving, after the trouble they have caused
I suggest they both stay silent. Don't start rumors. Stay out of it. I cannot
Leave perimeter of Nevada except to go to London until my aunt can get
Colorado shut down completely otherwise I could face imminent danger,
Both defendants are dangerous and a full federal investigation will
Happen in London and both defendants are paying for their own investigation,
Once they start paying they will stop doing it.

7. My aunt, JoAnn O'Neil will be making a direct progress report on both
Defendants directly to the courts and it is NOT going to be good. My aunt
Has to fix everything this little group has done, if they think its funny she'
Will request even further damages to be awarded, so I remind them, its in
Their best interest to start acting like mature responsible litigants in a

Court of law, as human trafficking is on the table and a new case may be Filed, if I hear another sound about movement that doesn't have anything To do with The CIA, neither of them are Federal agents, I suggest they Remain silent until my aunt determines how much trouble they have Intentionally caused, especially defendant deplorable O'Neil, the only Defendant O'Neil needs to be doing is obtaining a mental health assessment For the courts immediately because my aunt is going to rip her apart to the Court. Until this critical emergency situation is extinguished the only right They have is to remain silent and the plots and schemes to make things Bad here intentionally to force movement may cause a enormous new Human trafficking lawsuit, why are they trying to force movement? Are Both defendants mentally ill, both of them should be in home, they are old, Delusional, and are in desperate need of a mental health intervention, my Aunt may move a brand new lawsuit of human trafficking to the 8th judicial District directly to a judgment and defendant O'Neil can laugh about that.

8. My aunt is going to ask what are both defendants doing in Nevada to Begin with? Does Officer Joe Brancato want to answer this because we Know it's a cop doing it. Federal Human Trafficking Fines are in excess Of \$1,000,000. Both defendants should NOT be in Nevada.

9. Both defendants better not get caught fusing Colorado Powers from

Both are going Under Federal Investigation and defendant O'Neil has already has already Been caught because she is a known drug trafficker and drug informant. Everything they say or do will be used against them, just a reminder. I Have serious problems with Gloria Mazzoli trying to traffic me multiple Times, as she calls my aunt "the spy" well the spy is going make very Serious reports and both defendants are in big trouble for trying to make It bad here intentionally to force movement to do even more stuff to me. I have notebooks of evidence that will be reviewed and complaints will Go straight to a judgment.

10. Mobbing under the Patriot Act imposes fines in excess of \$250,000.

My aunt will be making a report and its going to be VERY BAD on BOTH. The courts are going to be blown away as to the REAL TRUTH of these Defendant's who are scheming new plots as we haven't even finished in Court and are planning new harm as when I return from London I will Updating her daily as to their progress since both defendants think they are Above the law and above the Feds, the courts will everything.

11. I cant even resolve the impact of what they have done and they are already Plotting out of state. This is another r charge and criminal charges are on the

Table since both defendants have no respect for the courts or the law. One Lives Florida and she better stay there, as each time she crosses into Nevada A Federal fine of \$250,000 is going to be added. The other one lives in NY And she is ancient, these woman are so old they become incoherent. There Actions speak loudly, it's the cop doing it, and both defendants are going To be caught with the cop, and further fines will be assessed.

12. Mazzoli had somebody talking to me on bus saying Im from Boston, Im not From Boston, but they are plotting an attack, they both raised the Terrorist watch list, both defendants raise it, they are plotting a attack in Boston, and that came from Mazzoli. Im only reporting there communications Why are they communicating with me about movement. I am guaranteeing A future trafficking lawsuit. They have went on a nationwide crime spree. Enough, they need to worry about themselves and their mental capacity Because my aunt is going to request an order this cop from official and All duties.

13. Both defendants, and Joe Brancato have been previously involved in Robbery. BOTH, instigating Morgan O'Neil to rob people, they encourage People to rob people. This conduct is OVER and this cop losing his job. The United States Federal Government does NOT run an adult day care Center for the emotionally and mentally impaired. These defendant's are

Dangerous, the list of crimes is outrageous. Until this activity stops here,
Fines will keep being added for aunt to address as she moves cases
Straight to judgement to teach the defendants as to who runs this country,
I don't know what the new plot is in Boston, I assume its much easier there
Informants but a plot is underway for a Federal investigation, both defendants
Can pay for security when I travel since they want to plot further harm.
Prevention will be mandated, I am done with this criminal activity.

14. Defendant O'Neil raped my sister's father. Which also provides
Exclusive further detail that defendant O'Neil is a UNTREARTED
Pedophile. Why is she not registered as a sex offender? The report
From Buffalo, New York clearly shows a female pedophile, a rare
Disorder and she has not been treated for this "disorder" in which we have
Very serious ongoing sexual harassment on myself which was preventable
And foreseeable.

15. Humans do not consume metal. We don't eat metal, our bodies do
Not digest metal, putting metal into one's body without the consulting
Of one's treating physician is questionable about one's judgement

16. Privacy, Im not allowed to go to the Strip in Las Vegas, and go
To the bathroom in public, what gives Mazzoli the right to overhear
And compromise my privacy to go to the bathroom or even worse

Who is so demented to want to listen to another person having sex and

How many people in that town know about this, quite a few.....

16. The defendant can listen in to medical appointments, surgeries,

Confidential conversations, after the Watergate Scandal one would

Question the impact of bugging and the potential harm brought on to

An organization but a person and their privacy, which provides a

Benefit of exploitation, they have a knowledge they should not possess

And took advantage by manipulation

17. Both defendant's have attempted to engage in sensory deprivation,

By attempting to interfere by depriving communication with family

And friends, my relationship, sex, and contact, there isn't a man on this

Planet who is going to sit with me knowing some mentally ill people in

New York are listening to our plans, conversations, finances and could

Potentially sabotage ones life. My own children wouldn't sit here and be

Bugged.

18. In a delusion, defendant O'Neil will NEVER under any circumstances

Ever communicate with me and refuses to accept this

19. Neither of these defendant's has post high education, no college, nothing

20. These two defendant's can play paparazzi to me while my daughter,

Morgan O'Neil is a known gang member in Syracuse, NY who has been

Convicted multiple times for heroin trafficking. Defendant O'Neil has
Taught her granddaughter the art of trafficking instead of discouraging,
If they have the power to prevent than why is she involved as a drug
Informant, she shoots heroin up everyday, she learned all of this behavior,
From defendant O'Neil, a known drug trafficker, they aren't bothering her.
She commits felonies everyday, they have the capability to stalk me but
They can't take down the Brickyard Gang, because Defendant O'Neil is
A known drug informant this conduct is considered ok for her to do it.

21. These two woman have one goal to influence people to do heinous
Acts of outrage to me, starting with my children, especially Morgan
O'Neil. They are manipulating con-artists, are they stopping Morgan
O'Neil from marriage

22. Why do the defendant's have the same attorney? These defendant's
Play off of each other, they pretend like they don't like each other and
Blame each other but are constantly conspiring together, why do they
Have the same attorney?

23. These defendant's create acts of heinous crimes in which victims
Will not be believed when they come forward

24. Its also believed that defendant O'Neil, after a new investigation,
That defendant O'Neil, the pedophile, also had Catherine Bebee ,

Who was my son's school psychologist, rape and molest him, new
Evidence after Mr. Leigh Hunt investigated, it is believed defendant
O'Neil, the pedophile had my son, Dylan Baker raped by Catherine
Bebbee.

25. These defendant's have cops who are not Feds or State Police,
But conspire heinous acts in which victims won't be believed

26. Here is the question for the court, if our defendant's can hear me,
Know my location why are they following me around like the paparazzi?
To mess with me, violate restraining orders, cause crime, intimidation,
If they can hear me and have a GPS why are they following me? For
The purpose of harassment, this as Mr. Hunt said, is holding someone
Hostage, lets remember Mr. Hunt, the retired head of The New York
State Police, and Retired Syracuse Police Chief, " ordered defendant
O'Neil to do what, " CEASE and DESIST." Has defendant O'Neil
Followed these instructions? So either defendant O'Neil is incoherent
Or mentally ill. She obviously has no respect for boundaries, the law,
The judicial system, and is a Narcissist who suffers from multiple
Mental health impairments. If The New York State Police called me and
Said, " do not contact your daughter, STOP," would I keep doing it,
Absolutely not, defendant O'Neil keeps repeating patterns of behavior

Over and over and over expecting a different outcome as she is delusional
And has no boundaries, evidence from Buffalo New York, identifies
Defendant O'Neil as having boundaries but to keep repeating the same
Thing over and over after being told by The retired head of The New
York State Police. Its obvious there is a serious mental health problem.

27. Federal agent Juan Serrata also caught the defendant's scheming at
My job, as defendant O'Neil, the pedophile, was having her own sexually
Harassed. Juan Serrata is a Federal Agent, he ordered them to STOP.

Is there a problem processing information, is it drugs, when somebody
Is ordered to STOP, you don't continue. These defendants have crossed
Invisible boundaries.

28. My Aunt JoAnn O'Neil, than catches them on another job. So far two
Federal Agents and The retired head of The New York State Police have
Caught them doing the same patterns of behavior and expecting a
Different outcome, the answer here is both defendant's are insane.

Just because you are does not mean you cannot be sued.

29. Obsessive compulsive disorders, as we see some significant
Obsessions. My daughter, Morgan O'Neil only dates deplorable heroin
Dealers, even got pregnant by a married one, and listen what our defendants
Did, one or both, they were rerouting her calls to an abortion clinic, as this

Man had a wife who was incarcerated by sales of heroin, heroin something,
And he went to The Department of Corrections over sales of heroin, he is
The 3rd male she has dated who has went to The NYS Department of
Corrections for sales of heroin; they rerouted her calls to what my
Daughter said was fake abortion clinics, like the human trafficking hotline
I have tried to call, as this man's wife got out of jail and went looking for
Morgan O'Neil and beat her up pretty bad. These defendant's don't judge
Her being heroin dealers but try to interfere with my relationship. Im not
Involved in heroin, she is. People die from shooting heroin up, if these
Two defendants had such GREAT concerns about humanity they would
Be intervening with heroin consumption as the last time I checked its
Against the law in New York, unless our defendant's these powerful
Woman have legalized the consumption of heroin, this just shows direct
Targeting, as they have no genuine concern about anyone but themselves.
There are only two ways out with heroin, death or prison, so one
Could argue there is no genuine concern.

30. So in other words, trying to conduct sensory deprivation, would be
An act of brainwashing. This would be used to erase my collegic
Knowledge that imposes a threat to their plots, this college degree cost
A significant amount of time and money....which both defendant's should

Be financially accountable for

31. In other words, if they are not able to gain control, than I can't talk
To children, unless I do as they say, these are serious mental health
Issues that need treatment. The scheme is to isolate with hopes of them
Gaining control.

32. Defendant O'Neil's nephew, Dr. Thom Lappas, has been adamant
That Morgan O'Neil, her family, her cohorts and these defendant's
Are dangerous. He has adamantly said for the past two years that this
Group, potentially would rob his mother, my aunt, Josephine Wahrendorf,
Defendant O'Neil's own sister. Morgan O'Neil works as a drug informant,
For Joe Brancato, it believed defendant O'Neil is either bribing Joe
Brancato or working as a drug informant, and its also believed defendant
Mazzoli is bribing this Joe Brancato, which directly compromises the
Safety interests of the public. Morgan O'Neil stole her sisters BMW,
That I purchased, and went on a high speed chase, having to shut down
The main street of that town, Oswego, NY, which is like shutting the
Strip, as she was high on heroin, on high speed, barricading the main
Compromises the health and safety of the public. My cousin has been
Adamant that this "group" could potentially rob his mother because
She lives there, so our defendants, in a scheme, wanted to control

My residence, but a Dr. has deemed the people in this group, as potentially Harmful, wouldn't this be a bad choice? It is believed that Morgan O'Neil, Who is obviously incapable of making logical decisions is involved with Both defendant's by trying to directly interfere in my life. Morgan is Deplorable. Her decision making skills are influenced by the use of Heroin, and Morgan O'Neil has been on my phone without a warrant Conditioning newsfeed, as its believed this group is all working Together.
