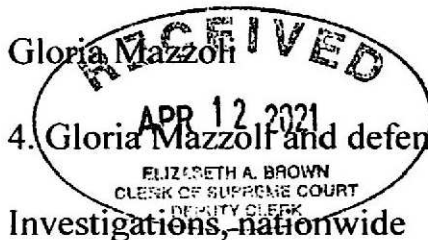

NOTICE OF MOTION

1. Gloria Mazzoli recently leaked sealed confidential records involving my Identity to the public and in the community of Oswego, NY
2. Gloria Mazzoli used New York State power to open a sealed adoption
3. Robert Natoli of Oswego, New York is my biological father. New York State is in Civil Court over this adoption at the 9<sup>th</sup> Circuit in San Francisco, New York State releases adoption records in confidential matters, NOT

4. Gloria Mazzoli and defendant O'Neil are both under several Federal Investigations, nationwide

5. I have secured an appointment for the removal of this eavesdropping device  
And this is also a Federal Investigation, as I am unable to see Dr's until this  
Is removed as it is a serious breach of medical confidentiality

6. Gloria Mazzoli wanted to exploit this adoption

7. After a long ongoing 2 year federal investigation that still is not complete,  
Mazzoli "influenced" a transport driver of a secured armored vehicle in  
Northern Arizona, by the misuse of this device. The Phoenix, Denver,  
Northern Colorado, and then my aunt, retired head of The London CIA,  
JoAnn O'Neil, reviewed multiple GPS records of the transport. Mazzoli  
Influenced the armored vehicle to be intercepted in the middle of nowhere,  
It turns out it was a Indian Reservation in Northern Arizona, then Mazzoli  
Attempted to cover the records up, and was caught attempting to forge GPS  
Records through Apache County. I was intercepted, kidnapped, raped, beaten  
All CONSPIRED, premeditated and plotted by Mazzoli which my aunt,  
Retired head of The London CIA said to move the lawsuit to a judgement,  
This is a crime of outrage. The photographs of my face, are so graphic, I  
Cant even view the photo's. I had blood sacks on my eyes. I lost my vision,  
My eyes were open and I was unable to see as I beaten with metal handcuff's  
In the eyes to DELIBERATELY take away my vision. At the time the report  
At Apache County said they were unsure if I would ever regain visual perception.

This is still under Federal Investigation as Mazzoli is looking at several other Federal Crimes. She “bugged” a armored secured vehicle, that is supposed to Provide safety.

Upon leaving Apache County, the driver at the 4 corners saw my face and said You better sue every single person involved, as the investigation to ensure Any other “conspirators” is still underway but Mazzoli, is once again the Ring leader. Than Mazzoli bugged a four hour interrogation with the FBI and Attempted, didn’t but there are notes of a attempt to influence a Public Servant, as the misuse of this device is now Federal Espionage, as she has Knowledge that is a mandatory life sentence in The US to bug a Federal Interrogation, than try to cover it up. They tried to cover up these records, My aunt has bumped it through, I was kidnapped. She is being sued in a Separate action. The Federal Victims Crimes Act states she is not Permitted to enter the state of my residence, because she is now under another Federal Investigation for espionage. She bis aware she is under investigation She is NOT to be sending 3<sup>rd</sup> party people anywhere near me. It also says she Will compensate without trial to the fullest extent for a crime of outrage. My Eyes were so badly beaten they couldn’t close and I had no vision. The point Ton recognize, is the “conspiring” there is a significant problem with a Person conspiring major Federal Crimes. Mazzoli has admitted to this, she

Knows she is under investigation and she knows she is NOT supposed to be  
In Nevada, she doesn't need a formality, she resides in New York State. Her  
Attorney, Kevin Beck has been told several times about restraining his  
Clients to their home states. Now after signing the Crime Victim's Act,  
She is not permitted in the state I reside in, or the location of EMPLOYMENT,  
Or residence.....If defendant Mazzoli is unable or incoherent, we said this  
Dozens of times and it's the responsibility of Mr. Beck to enforce the rules.  
One of the defendant's is influencing roommates. Under the 4<sup>th</sup> Amendment,  
I have the right to be secure in my persons and home, we have had this ongoing  
Problem, there both restrained and both communicating through other people.  
THEY ARE NOT to communicate, are they both mentally ill? We have said  
This a 100 times and both defendants continue to display delusional behavior.  
A order is a order. Mr. Beck is required to reinforce this

8. Defendant O'Neil had a third party person assault at The 8<sup>th</sup> Judicial  
District yesterday, there are cameras. She has females hit me hard with their  
Purse. Its ongoing mental illness. One of them is influencing and the violating  
The 4<sup>th</sup> Amendment.

9. The misuse of GPS compromises the safety of society, that's why this  
File is two feet high and Mazzoli is under dozens of investigations. Public  
Movements generate a location revealing a wealth of detail about marriage,

Family, employment, medical, political and professional. *US v. Jones*,  
82% of American's feel GPS is sensitive information to one's location.  
This draws significant safety as we can seriously see. If anyone in the  
World tunes a radio, Am to 1040 I could be heard for miles, this could be  
Terrorists, gang members, putting a group of people inadvertently at risk.  
This draws immediate safety concerns as to how a private person reached  
A potential level of threat, they could dispatch my location, as they do  
Everyday causing significant safety concerns. GPS is required by a warrant.  
The warrant must be valid with a time, expiration, I have a right to see it,  
And in this case there isn't a warrant. It is not being monitored it is being  
Misused. This violates the right to be secure in the person, papers, and  
Effects. Physical intrusion of effect for the purpose of gaining information  
Is warranted, it must have a valid warrant.

10. Trespass is a reasonable expectation of privacy and electronic monitoring  
*NY v. Class*. The monitoring device is a search a reasonable one. There must  
Be a warrant maintained in all aspects of professionalism regulated by a  
Standard. This constitutes a search, requiring a ongoing warrant. This also  
Violates the expectation of privacy. *Id @ 360 Bond v. US* 529 US 334 2000.

11. *Katz v. US* 389 US 347 trespassing onto a person including medical. The  
Fourth Amendment protects persons from private conversations such as a Dr.



Such as your husband, as I am married, defendant O'Neil tries to breach that Covenant.

12. Non-consensual installation violates due process and equal protection.

It requires an indictment, and it must be a formal one.

13. Both defendants require a warrant to enter any place of employment

D. Warrant dates, times, locations, such as we cant bug a FBI interrogation  
That is why it is warranted

14. A eavesdropping device, requires a FEDERAL WARRANT, no state

Or local government is permitted to handle a eavesdropping warrant. There

Is no federal warrant, this is completely illegal, if not handled through the

Federal Government.

15. Harlan Standards

A. A individual has a reasonable expectation of privacy, an actual expectation

B. The expectation is one that society is prepared to recognize as reasonable

Society doesn't recognize this as reasonable. This is a direct violation of The

4<sup>th</sup> Amendment. Information transferred can convey to a 3<sup>rd</sup> party dangerous

Data; in the wrong hands anywhere in the world, someone could hear everything

Im doing, such as finances, credit card numbers, social security numbers,

Medical information, security codes, tax information; a random phone call  
Could be overheard in China. Can someone please release the warrant that  
Is regulated by a Federal Eavesdropping warrant? There is no warrant,  
There is no regulation, someone in the Europe could plot anything and lets  
Discuss the liability? Mazzoli is civilly liable for all acts regarding this device.  
Defendant O'Neil, knows about it and is failing to report

16. Defendant O'Neil lied about my identity, my birthdate, my father and  
Allowed Mazzoli to disclose sealed records nationwide. Both defendants are  
Under Federal Investigations.

17. The United States Supreme Court ruled in the US v. Jones, an unregulated  
GPS, not eavesdropping, as eavesdropping is only handled by the FEDS  
With a special warrant, compromises the health and safety of a citizen,  
Careful watch is required for ongoing maintenance of the warrant.

18. The entire world, can hear when I go for my passport appointment,  
Where and when Im flying out, or getting my income taxes done as I  
Am afraid to.

18. This will be the final time I say this, I was married in Colorado,  
I do not need to disclose this, this device is causing economic instability  
In a stable marriage

19. I contacted Mr. Natoli and advised him that Mazzoli is leaking sealed

Records nationwide and the pursuance of civil, criminal and whatever he  
Chooses to do I support and encourage, Mazzoli has opened a can of worms  
That could cost her to never leave her house. Natoli is the richest and most  
Powerful in that town, maybe the state, he has beyond governor status and'  
She is making very serious bad decisions that she needs to be held accountable

20. Both defendants have been advised by multiple agents that they financially  
Responsible for any and all economic harm they conduct and induce these  
Two defendants are NOT supposed to trespass. Apparently Mazzoli is bored,  
As she is having party person communicate she is bored, Ill pass that on to  
The FBI after Federal Espionage Reports were filed for eavesdropping during  
A four hour FBI interrogation. Anyone can tune in a hear conversation,  
Do NOT continue sending messengers to communicate crazy conversations.
