MOTION TO SUBMIT VIDEO EVIDENCE


This appeal is from an order granting judicial review which reversed a Hearing Officer's decision to reinstate terminated Forensic Specialist Charles Rocha. The underlying termination involved an attack upon the Rocha by an inmate/patient at Stein Hospital which is the Southern Nevada facility where criminal defendants are detained when they have been deemed psychiatrically incapable of standing trial.

The attack, and what Charles Roca contends was his legitimate use of force in self-defense, was caught on video (without audio) and played at Rocha's appeal hearing before the Hearing Officer. The Opening Brief and Appendix are currently

due on August 5, 2021.¹ Appellant believes that the video would be of assistance to the Court in deciding the case and requests leave to submit video on a flash drive, or in whatever other form the court designates.


