This appeal is from an order granting judicial review which reversed a Hearing Officer's decision to reinstate terminated Forensic Specialist Charles Rocha. The underlying termination involved an attack upon the Rocha by an inmate/patient at Stein Hospital which is the Southern Nevada facility where criminal defendants are detained when they have been deemed psychiatrically incapable of standing trial.

The attack, and what Charles Roca contends was his legitimate use of force in self-defense, was caught on video (without audio) and played at Rocha's appeal hearing before the Hearing Officer. It was designated as Exhibit "5" at the appeals hearing. Appellant believes that the video would be of assistance to this Court in deciding the case and requests that this Court direct the District Court Clerk to transmit the video, Exhibit "5" from the Appeals hearing, to the Supreme Court. If for some reason the Department of Administration did not file the video with the District Court, then the order to the District Court should direct the District Court to order the Department of Administration to provide Exhibit "5" so that the District Court may transmit it to this Court.
