

MOTION TO EXPAND THE RECORD ON APPEAL AND/OR TO REMAND

Docket 78760 Document 2020-07012



ARGUMENT

Mr. Slaughter respectfully requests the Court expand the record on appeal or, in the alternative, remand this case for further proceedings.

Under this Court's rules, the record on appeal includes relevant portions of the trial court record. Nev. R. App. P. 10. The rules don't explain whether and in what circumstances the Court may expand the record to include additional evidence, and this Court has previously suggested it may lack the ability to expand the record on appeal. See, e.g., Carson Ready Mix. Inc. v. First Nat. Bank of Nevada, 97 Nev. 474, 476-77, 635 P.2d 276, 277-78 (1981). But federal appellate courts have "inherent authority in extraordinary cases" to consider new evidence that wasn't submitted to the lower court. United States v. W.R. Grace, 504 F.3d 745, 766 (9th Cir. 2007) (cleaned up); see also Turk v. United States, 429 F.2d 1327, 1329 (8th Cir. 1970). Likewise, this Court should conclude it has inherent authority to expand the record on appeal in extraordinary cases, and it should exercise that authority here. At the very least, this Court should conclude it has inherent authority to consider an expanded record when evaluating a request for a remand.

As Mr. Slaughter's briefs explain, there's newly discovered evidence relevant to the issues on appeal. After the lower court announced its intent to dismiss Mr. Slaughter's petition, the federal court granted Mr. Slaughter leave to depose the lead prosecutor (Marc DiGiacomo). XIII.App.2729-38. Promptly following that order, Mr. Slaughter filed a motion proposing the lower court decline to enter a written order and instead allow Mr. Slaughter to supplement his petition after the deposition occurred. XIII.App.2739-43. The lower court didn't resolve that motion but went ahead and entered a formal written order; it still hasn't resolved the motion.

After this appeal began, Mr. Slaughter took Mr. DiGiacomo's deposition, and he then engaged in follow-up investigation prompted by the deposition. The deposition and the results of the investigation aren't part of the record on appeal, so Mr. Slaughter doesn't discuss it in his briefing. Rather, Mr. Slaughter suggests the Court remand this case so the lower court can consider this evidence in the first instance. But because the evidence is directly relevant to the issues on appeal, and in the interests of full disclosure, Mr. Slaughter is filing the instant motion to ensure the Court is aware of the evidence. The proposed expanded record includes Mr. DiGiacomo's deposition (Exhibit A), the accompanying deposition exhibits (Exhibit B) (which Mr. Slaughter is manually filing), a declaration from trial counsel (Exhibit C), and a declaration from a staff investigator regarding the investigation (Exhibit D).

If the Court expands the record, supplemental briefing may be appropriate. As an offer of proof, Mr. Slaughter provides a brief discussion of the evidence, why it's relevant on appeal, and why the Court should remand so the lower court can consider it.

Mr. Slaughter's briefing explains how the State withheld evidence about the second photo lineup. Some eyewitnesses identified Mr. Slaughter from a first, suggestive lineup. The police then showed the eyewitnesses a second lineup that happened to include Mr. Slaughter's picture. The State didn't tell the defense the outcome. In 2018, Mr. Slaughter learned for the first time during Detective Prieto's deposition that none of the eyewitnesses identified him from the lineup. The State therefore violated its obligations under *Brady v. Maryland*, 373 U.S. 83 (1963), by failing to disclose the lineup's exculpatory outcome.

In his deposition (Exhibit A), Mr. Slaughter questioned Mr. DiGiacomo about the second photo lineup. According to Mr. DiGiacomo, he learned about the second lineup in a pre-trial interview with one of the witnesses at some point in 2004 or 2005. Mr. DiGiacomo couldn't recall which witness, but he thought it was Mr. Young; he also suggested Jennifer Dennis (and maybe Aaron Dennis) might've been present. Exhibit A at 69.70. At the meeting, Mr. DiGiacomo asked the witness (probably Mr. Young) about photo lineups, and the witness said he recalled seeing a second lineup with Mr. Slaughter's photo in it. Id. at 70, 73, 77. That was news to Mr. DiGiacomo. After the meeting, he called Detective Prieto at least once (possibly twice) and expressed his displeasure that Detective Prieto had mistakenly shown the witnesses a second lineup with Mr. Slaughter's photo in it. Id. at 79, 201. During this conversation, Detective Prieto seemed surprised to learn Mr. Slaughter's photo was in the second lineup. Id.

After that conversation, Mr. DiGiacomo reached out to the other eyewitnesses about the second lineup. Exhibit A at 86. Mr. DiGiacomo couldn't say whether any of the other witnesses, aside from the initial witness (probably Mr. Young), said they recognized Mr. Slaughter's photo in the second lineup. *Id.* at 86-88, 195-97. All Mr. DiGiacomo could say is at least one witness (probably Mr. Young) mentioned recognizing Mr. Slaughter in the second lineup. *Id.*

Mr. DiGiacomo said he gave the defense copies of the second lineup and mentioned Mr. Slaughter's picture was in it. Exhibit A at 85-86, 120-22, 187. Mr. DiGiacomo admitted he didn't specifically tell the attorneys one of the witnesses recognized Mr. Slaughter from the second lineup, while the others didn't. *Id.* at 120-22.

Mr. Slaughter disputes this account. It's exceedingly unlikely Mr. DiGiacomo conducted a pre-trial interview with a witness who claimed to have recognized Mr. Slaughter in the second photo lineup. Rather, Mr. Slaughter maintains none of the witnesses recognized him from the second photo lineup, which is what Detective Prieto said in his testimony.

To start, it doesn't make sense a witness would recognize Mr. Slaughter in the second lineup but fail to disclose that fact to Detective Prieto. If a witness saw a suspect in the lineup, the witness would probably tell the police officer. It defies common sense to think a witness would've spotted Mr. Slaughter but not said anything to the officer.

Mr. DiGiacomo's explanation is also inconsistent with Detective Prieto's testimony. According to Mr. DiGiacomo, he called Detective Prieto about the lineup and "express[ed]" to Detective Prieto his "displeasure that this had occurred in this particular case." Exhibit A at 79. But Detective Prieto didn't mention any conversations like that in his questioning. He probably would've remembered if Mr. DiGiacomo had yelled at him and probably would've divulged that in response to Mr. Slaughter's question. The fact Detective Prieto didn't mention this call in his testimony suggests it didn't happen. (Assuming the call took place, Mr. DiGiacomo said Detective Prieto didn't seem to realize Mr. Slaughter was in the second lineup. That implies none of the witnesses identified Mr. Slaughter to Detective Prieto when he showed them the second lineup, which corroborates Detective Prieto's testimony.)

Other witnesses don't back up Mr. DiGiacomo's account. The original lead prosecutor doesn't remember anything about the photo lineups. Exhibit D ¶ 22. A staff investigator for Mr. Slaughter was able to contact two eyewitnesses, neither of whom verified the account. *Id.* ¶¶ 5-13. Mr. Slaughter's trial lawyers don't remember hearing from Mr. DiGiacomo about the second lineup. Exhibit C ¶¶ 4-5; Exhibit D ¶ 16. Nor are there any notes, documents, written filings, statements in open court, or other evidence memorializing this version of events. Exhibit A at 90-92.

In all, the Court shouldn't credit Mr. DiGiacomo's testimony; rather, it should conclude none of the witnesses identified or recognized Mr. Slaughter in the second lineup. But even if Mr. DiGiacomo's testimony were entirely truthful, it *still* confirms a *Brady* violation occurred. Mr. DiGiacomo's testimony suggests only one witness (Mr. Young) claimed to recognize Mr. Slaughter in the second lineup. Exhibit A at 77 ("[T]hat tends to make me think it was Ivan that told me this."); *id.* at 86-88. The failure to disclose that information amounts to a *Brady* violation.

First, this account casts doubt on Mr. Young's credibility. It's odd that he would apparently recognize Mr. Slaughter in the second lineup, fail to mention that to Detective Prieto, and then mention it to Mr. DiGiacomo months later. The account therefore suggests Mr. Young isn't a reliable witness. Second, the account is indisputably exculpatory regarding the other witnesses who *didn't* recognize Mr. Slaughter in the second lineup, including three of the four witnesses who claimed to see him in the first lineup. Indeed, Mr. DiGiacomo agreed the second lineup was exculpatory with respect to those witnesses. Exhibit A at 48-49, 57, 98, 119, 195-98. Mr. DiGiacomo therefore knew in 2005 that the second lineup was substantially exculpatory. And yet he made a conscious decision, "on purpose," not to disclose the outcome to the defense. Exhibit A at 119; *see also id.* at 187-88. Perhaps that's because the second lineup makes Detective Prieto look like a bad detective who performed a sloppy investigation. Exhibit A at 97 (calling the issue a "red herring"); *id.* at 184-85.

As this discussion explains, the evidence in the proposed expanded record is material, and it confirms the State committed a *Brady* violation. Again, if the Court is inclined to expand the record, Mr. Slaughter would propose supplemental briefing regarding these issues.

The proposed expanded record is also important because it undermines some of the assertions in the State's answering brief. For example, the State argues Mr. DiGiacomo didn't knowingly misrepresent the outcome of the second lineup at a pre-trial hearing in 2009; according to the State, Mr. DiGiacomo at the time had the same information as the defense about the lineup. AB at 29. Quite the opposite: according to Mr. DiGiacomo, he had detailed information about the outcome as early as 2005, but he never shared this information with the defense.

Similarly, the State argues Detective Prieto's testimony is ambiguous about whether any of the witnesses identified Mr. Slaughter from the second lineup. AB at 29.31. To the contrary, Mr. DiGiacomo testified that when he spoke to Detective Prieto about the second lineup, Detective Prieto seemed unaware Mr. Slaughter's picture was in the second lineup, which necessarily means none of the witnesses identified Mr. Slaughter to Detective Prieto from the lineup.

Next, the State argues the defense attorneys might've had a strategic reason not to address the second lineup. AB at 26, 32. To the contrary, Mr. Slaughter's lead defense attorney submitted a declaration stating he would've used the information if he'd known it. Exhibit C ¶¶ 4-5.

Finally, the State suggests some of the eyewitnesses might've recognized Mr. Slaughter in the second lineup but failed to mention him to Detective Prieto. AB at 32. On its face, Mr. DiGiacomo's deposition implies at most that could've happened with Mr. Young. But as this motion explains, that's not a believable version of events. Even if it is, Mr. Young is probably the only witness who made that claim, and the failure to disclose the outcome regarding all the witnesses was a *Brady* violation.

In short, the proposed expanded record is relevant to the issues on appeal and undercuts many of the State's arguments. The Court should expand the record on appeal or, in the alternative, remand this case so the lower court can consider this evidence in the first instance.

CONCLUSION

The Court should expand the record on appeal or remand this case.

DECLARATION OF OSVALDO FUMO

I, Osvaldo Fumo, do hereby declare as follows pursuant to 28 U.S.C. § 1746:

- 1. I am an attorney licensed to practice in the State of Nevada.
- 2. Along with Dustin Marcello, I represented Rickie Slaughter during his trial in the Eighth Judicial District Court in Case No. C204957.
- 3. I understand Mr. Slaughter is currently pursuing a federal habeas petition and has raised claims involving the photo lineups the police created in this case. I understand some of the claims involve a "second photo lineup" that included a picture of Mr. Slaughter along with a picture of an alternate suspect. A copy of the second photo lineup is attached to this declaration as Exhibit 1.
- 4. I don't recall knowing in advance of trial whether any of the eyewitnesses identified Mr. Slaughter from the second photo lineup. I don't recall our office attempting to contact the eyewitnesses before trial to ask them about the second photo lineup.
- 5. I don't recall having any conversations with Marc DiGiacomo, Michele Fleck, or other members of the District Attorney's office about the second photo lineup before, during, or after trial. Had the prosecutors told us before or during trial that some or all of the eyewitnesses failed to identify Mr. Slaughter's photo from the second photo lineup, we would've crossexamined the eyewitnesses about their non-identifications during trial. We also would've given that information to our eyewitness identification expert in advance of his trial testimony.
- 6. I understand Mr. Slaughter has received certain documents through the discovery process in federal court, including the documents attached to this declaration as Exhibits 2 and 3.
- 7. I have reviewed Exhibits 2 and 3. I don't recall receiving either of these exhibits as part of the discovery provided to our office by the State in Mr. Slaughter's case.
- 8. Our office's standard practice in criminal cases like Mr. Slaughter's is to save any and all discovery we receive from the State to our client's file. When a former client files a federal petition and counsel is appointed to assist the client in the federal case, our standard practice is to provide federal counsel with a complete copy of the client's file. If Exhibits 2 and 3 aren't part of that file, the State must not have turned them over to us before or during trial.

9. I recall arguing at Mr. Slaughter's trial that he had an alibi, specifically that he was picking his girlfriend up from work at about the same time as the charged crimes occurred. Had we received Exhibits 2 or 3 before or during trial, we would have used them as part of the alibi defense.

I declare under penalty of perjury that the foregoing information is true and correct to the best of my knowledge.

DECLARATION OF MARIBEL YANEZ

I, Maribel Yanez, do hereby declare as follows pursuant to 28 U.S.C. § 1746:

- 1. I am a staff investigator with the non-capital habeas unit of the Federal Public Defender, District of Nevada.
- Assistant Federal Public Defender Jeremy C. Baron represents Rickie Slaughter in his federal habeas proceedings. *Slaughter v. Baker*, Case No. 3:16-cv-00721-RCJ-WGC (D. Nev.). I've been assigned to assist with the investigation of this case.
- 3. I understand Mr. Slaughter has raised claims involving the photo lineups the police created in this case. I understand some of the claims involve a "second photo lineup" that included a picture of Mr. Slaughter along with a picture of an alternate suspect. I understand Mr. Slaughter deposed the lead prosecutor, Marc DiGiacomo, who testified at least one eyewitness told him he recognized Mr. Slaughter in the second photo lineup. Mr. Baron instructed me to make all reasonable efforts to locate and interview a series of witnesses who may have relevant knowledge regarding Mr. DiGiacomo's testimony.

Ivan Young and Jennifer Dennis

4. Mr. Baron and I went to an address I believe to be Ivan Young and Jennifer Dennis's home. Ms. Dennis answered the door. We explained we represented Mr. Slaughter in his federal habeas proceedings. Ms. Dennis let us in but soon stated she wasn't willing to talk to us unless she received a subpoena. She said she spoke for Mr. Young, who would tell us the same thing. We ended the conversation and left at that point.

<u>Ryan John</u>

- 5. Mr. Baron and I went to an address I believe to be Ryan John's workplace. Mr. John was present when we walked in. We explained we represented Mr. Slaughter in his federal habeas proceedings.
- 6. Mr. John recalled he had identified Mr. Slaughter from a photo lineup. Mr. Baron showed him a copy of a lineup referred to in Mr. Slaughter's federal petition as the "first photo lineup." Mr. John said he recognized the document as a photo lineup he'd previously seen and proceeded to point out Mr. Slaughter's photo in that lineup.
- 7. Mr. John recalled the police showed him a second photo lineup. Mr. John said he hadn't identified anyone from that lineup. Mr. Baron showed him a copy of the second photo lineup. He said he didn't recognize the second

photo lineup. He didn't say or do anything indicating he recognized Mr. Slaughter's photo in that lineup.

8. Mr. John didn't recall meeting with the prosecutors, including Mr. DiGiacomo, before trial.

Jermaun Means

- 9. I went to an address I believe to Jermaun Means's home on multiple locations and eventually left a card with my telephone number. A man who identified himself as Jermaun Means called me back on that number. Mr. Baron was present for the phone call. We explained we represented Mr. Slaughter in his federal habeas proceedings.
- 10. Mr. Means said he remembered the police coming to his house and showing him a lineup. He said he recognized the suspect in that lineup. He said he was hesitant to identify the picture to the police, but the police officer told Mr. Means if he identified the suspect in the lineup, Mr. Means wouldn't have to do anything else with respect to the case. Mr. Means said that turned out not to be true.
- 11. Mr. Means didn't recall being shown any other lineups by the police.
- 12. Mr. Means said he went to the District Attorney's office on a few occasions. He said he didn't remember specifically with whom he met. He said he would've gone once right before the first time the trial was set, and another time shortly before the actual trial. He said the person he spoke with at the DA's office didn't ask him any questions about photo lineups, although the person asked him question about his ability to identify Mr. Slaughter.
- 13. Mr. Baron asked whether Mr. Means would be willing to meet with us in person to discuss these issues. Mr. Means declined.

J.P. and A.D.

- 14. I went to an address I believe belongs to the individual referred to in the federal proceedings as "A.D." The man who opened the door said A.D. had moved to Texas and gave me his phone number. I called this phone number on two occasions and left messages, but A.D. never called back.
- 15. I attempted to locate an address for the individual referred to in the federal proceedings as "J.P." The search suggested J.P. lives in Oregon. I located a number associated with J.P. I called the number on two occasions and left messages, but J.P. never called back.

Osvaldo Fumo and Dustin Marcello

16. I was present for an in-person meeting between Mr. Baron, Osvaldo Fumo, and Dustin Marcello. I have reviewed the declaration Mr. Fumo signed. The declaration is consistent with the statements Mr. Fumo made during this meeting. His declaration is also consistent with the statements Mr. Marcello made during this meeting.

Craig Retke

17. I was present for a phone call between Mr. Baron and Craig Retke. Mr. Baron asked Mr. Retke whether he recalled anything regarding the second photo lineup. Mr. Retke said he didn't. Mr. Baron asked whether Mr. Retke spoke with the eyewitnesses before trial. Mr. Retke said he prepared memoranda for the witness interviews he conducted in this case, and he forwarded Mr. Baron a set of those memoranda. I have reviewed those documents, and none of them involves any of the eyewitnesses.

Susan Bush

18.I was present for a phone call between Mr. Baron and Susan Bush. Ms. Bush recalled Mr. Slaughter's case but stated she didn't remember any issues regarding the photo lineups.

Patrick McDonald

19.I was present for a phone call between Mr. Baron and Patrick McDonald. Mr. McDonald said he vaguely recalled litigating an issue regarding the second photo lineup. He said he wouldn't have had any off-the-record conversations with Mr. DiGiacomo about that issue.

Paul Wommer

20.1 was present for a phone call between Mr. Baron and Paul Wommer. Mr. Wommer didn't recall issues involving the photo lineups in the case.

Michelle Fleck

21. I was present on two occasions when Mr. Baron left voicemail messages for Michelle Fleck on her work phone number. Mr. Baron explained he represented Mr. Slaughter in his federal habeas proceedings and requested a call back. To my knowledge, Ms. Fleck hasn't returned Mr. Baron's messages.

<u>Susan Krisko</u>

22. I was present for a phone call between Mr. Baron and Susan Krisko. Ms. Krisko said she didn't remember anything about the second photo lineup. Ms. Krisko also said she didn't remember anything about lineups in the case generally.

23. Ms. Krisko said she did recall Mr. Slaughter's case and recalled testifying in connection with Mr. Slaughter's ultimately successful attempt to withdraw his guilty plea.

Jessie Prieto

- 24.I called Jessie Prieto and asked whether he would be willing to meet with me and Mr. Baron informally. Detective Prieto initially said he would be willing to meet with us. Shortly after, I was present for a phone call between Detective Prieto and Mr. Baron. Detective Prieto asked us to contact the city attorney's office for North Las Vegas before speaking to him further. Mr. Baron said he would do that.
- 25. Shortly after that call, Detective Prieto called me directly and stated he was unwilling to speak with us further.
