

DANIEL MARTINEZ, hereby declares as follows:

I am an attorney duly licensed to practice law in the State of Nevada. Beginning in July of 2018, I was one of the contracted public defenders for Nye County, Nevada. During that time, I was appointed to represent E.S. in his juvenile case, including as the Respondent in the instant matter.

In April of 2021, I terminated my public defender contract with Nye County. Nadine Morton was subsequently awarded the public defender contract, and in July of 2021, was substituted in for all my clients under the Nye County public defender contract, including E.S. Since that time, hearings have been held in the Fifth Judicial District Court during which E.S. has been informed, and consented to, Nadine Morton's appointment to his cases, including as the Respondent in the instant matter.

I declare that I make this substitution in good faith and not for purposes of delay.

NADINE MORTON, hereby declares as follows:
