The order I am appealing Final Order and Decision covers all 21 hearings in the District Court covering a period from 10-2017 till 1-29-2021.

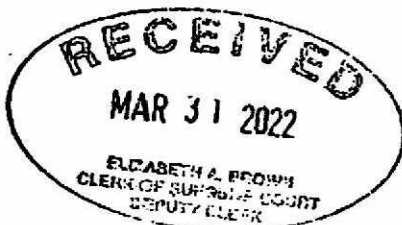
