



PETITIONER IS A MALE-TO-FEMALE TRANSGENDER PRISONER WHO REMAINS UNDER HORMONE TREATMENT DIAGNOSED WITH GENDER DYSPHORIA AND WHOM IDENTIFIES AS A WOMAN<sup>1</sup>. PRIOR TO INSTALLING HER NAME CHANGE PETITION AND IN AN UNRELATED FEDERAL CIVIL MATTER, THE FEDERAL MAGISTRATE OBSERVED THE URGENCY OF ADDRESSING PETITIONER IN THE FEMININE CONTEXT UTILIZING PROPER PRONOUN (SEE EXHIBIT "H" HERETO AT FN. 1).

PETITIONER FILED THE NAME CHANGE PETITION IN THIS ACTION MARCH 05, 2020 AND UNEQUIVOCALLY CONVEYED AT PAGE 2 OF HER PETITION "✓ I WANT TO CHANGE MY NAME TO CONFORM TO MY GENDER IDENTITY" (SEE EXHIBIT 'A' AT P. 2). ON MARCH 09, 2020 THE COURT GRANTED HER IN FORMA PAUPERIS STATUS ALLOWING THE ACTION TO PROCEED. (EXHIBIT 'B'). CONTEMPORANEOUS WITH DOING SO, HONORABLE JUDGE WILLIAM S. POTTER'S LAW CLERK SERVED PETITIONER WITH THE CONTENTS CONTAINED AT EXHIBIT 'C' WHICH IN SHORT ADVISED PETITIONER THAT THE COURT "DOES NOT SIGN ORDERS FOR CHANGE OF NAME FOR PERSONS CONVICTED OF A FELONY WITHOUT THE PETITIONER APPEARING IN COURT." THE CORRESPONDENCE COACHED PETITIONER IN TERMS OF SCHEDULING THE MATTER ON THE COURTS UNCONTESTED CALENDAR, *ID.*

1. PETITIONER IS IN THE PROCESS OF OBTAINING CONFIRMING NDOC MEDICAL RECORDS TO SUPPORT THIS CONTENTION AND WILL DILIGENTLY SUPPLEMENT THE INSTANT MOTION UPON HER RECEIPT OF SAME.

EXERCISING DUE DILIGENCE, ON MARCH 19, 2020 PETITIONER CORRESPONDED WITH CLERK TAPA TYLER (THE AUTHOR OF THE CORRESPONDENCE CONTAINED AT EXHIBIT 'C') CANDIDLY REQUESTING A PRINT CARD, SCHEDULING ORDER DOCUMENT AS WELL AS A MOTION AND ORDER TO TRANSPORT PRISONER GIVEN HER INCARCERATION STATUS. PETITIONER RECEIVED NO RESPONSE TO HER INQUIRIES. ON MAY 21, 2020 AFTER RECEIVING EXHIBIT 'D' SHE FILED A MOTION FOR ORDER OF THIS COURT DIRECTING NDOC TO MAKE PROVISION OF HER FINGER PRINTS TO THE COURT FOR PURPOSES OF THESE PROCEEDINGS. AGAIN, NO ANSWER WAS FORTH COMING AND THE RECORD WENT DORMANT.

IN AN ABUNDANCE OF CAUTION AND REMAINING DULY DILIGENT, PETITIONER ON JULY 29, 2020 FOLLOWED UP FILING HER SECOND NAME CHANGE PETITION PROMPTED BY HER GENDER DYSPHORIC SERIOUS MEDICAL CONDITION AND DESIRE TO CONFORM WITH HER GENDER IDENTITY (EXHIBIT 'E', P.2 (CASE NO. D-20-611509-N). SUBSEQUENTLY, 2 1/2 MONTHS LATER ON OCTOBER 08, 2020 HONORABLE POTTER'S JUDICIAL ASSISTANT CINDY MARSHALL IN CASE NO. D-20-611509-N, PROVIDED PETITIONER THE CONTENTS CONTAINED AT EXHIBIT 'F' HERETO CONVEYING THAT THE COURT REVIEWED AND WAS DENYING HER NAME CHANGE PETITION AS HONORABLE POTTER HAD A POLICY OF NOT APPROVING NAME CHANGES FOR INCARCERATED PETITIONERS WITHOUT APPROVAL OF NDOC AND ENCOURAGING PETITIONER TO OBTAIN A NOTICE OF NON-OPPOSITION FROM NDOC OTHERWISE DIRECTING THAT SHE MUST WAIT UNTIL RELEASE. ID.

FOLLOWING PETITIONER'S RECEIPT OF EXHIBIT 'F' ON OCTOBER 20, 2020 THE COURT ENTERED AN ORDER OF DISMISSAL IN THIS CASE WITHOUT PREJUDICE PURPORTEDLY DUE TO:

"FAILURE TO TAKE ACTION FOR MORE THAN 3 MONTHS ON A CASE THAT HAS BEEN PENDING FOR MORE THAN 6 MONTHS. EDCR 5.525 CASES DISMISSED UNDER THIS RULE MAY BE REACTIVATED WITHIN 30 DAYS UPON WRITTEN REQUEST OF A PARTY OR PARTY'S ATTORNEY."

IN FULL SATISFACTION OF EDCR 5.525 AND WITHIN THE REGULATORY 30 DAYS, PETITIONER HEREBY SEEKS RECONSIDERATION OF THIS COURTS OCTOBER 20, 2020 ORDER DISMISSING THE MATTER ON THE BASIS THAT THE ORDER RESTS ON CLERICAL MISTAKE, OVERSIGHT, OMISSION, MISTAKE, INADVERTENCE, SURPRISE AND/OR EXCUSABLE NEGLIGENCE. MOREOVER, SHE IS BEING PROVIDED CONFLICTING INSTRUCTIONS AS TO HOW TO PROCEED.

IN 1 INSTANCE SHE IS ADVISED THAT THE COURT DOES NOT SIGN ORDERS FOR NAME CHANGE FOR FELONS ABSENT PERSONAL JUDICIAL APPEARANCE AND IS ENCOURAGED TO PLACE HER MATTER ON THE UNCONTESTED CALENDAR (EXHIBIT 'C'). IN STARK CONTRAST, IN CASE NO. D-20-611509-N SHE IS ADVISED THAT THE COURT HAD A POLICY OF NOT APPROVING NAME CHANGES FOR STATE CUSTODY PETITIONERS WITHOUT NDOC APPROVAL CONCLUDING OTHERWISE THAT SHE MUST WAIT UNTIL RELEASE (EXHIBIT 'F'). FINALLY, AGAIN INJECTING CONFUSION IN THIS CASE IS THE ORDER OF DISMISSAL CONTAINED AT EXHIBIT 'G' WHICH JUSTIFIES AND RATIONALIZES THE DISMISSAL TO BE BASED ON PETITIONER'S PURPORTED FAILURE TO TAKE ACTION FOR MORE THAN 3 MONTHS ON A CASE THAT HAS BEEN PENDING FOR MORE THAN 6 MONTHS.

BASED UPON HER FIRST HAND OBSERVATION OF AT LEAST 3 OTHER CASES WHICH PROCEEDED BEFORE THE COURT, PETITIONER HAS CONSISTENTLY OBSERVED THE COURTS LACK OF UNIFORMITY IN STERN APPLICATION OF AND EXCEPTIONAL DEVIATION FROM SAID PRACTICE IN INSTANCES IN WHICH NAME CHANGES SOUGHT TO BE EFFECTED PEST AND ARE BASED ON MEDICAL NECESSITY (IE., GENDER DYSPHORIA -- TO CONFORM TO ONE'S GENDER IDENTITY).

CASE IN POINT FOR INSTANCE, IN CASE NO. D-20-607676-N THE PETITIONER, ALSO A TRANSGENDER NDOC PRISONER, FILED THE NAME CHANGE PETITION MAY 15, 2020 SEEKING TO CONFORM HER NAME TO HER GENDER IDENTITY (EXHIBIT 'I'). JUDGE POTTER GRANTED HER IFP APPLICATION JUNE 09, 2020 (EXHIBIT 'J'). THE PETITION WAS AMENDED TO REFLECT HER SIGNATURE ON JUNE 25, 2020 (EXHIBIT 'K') AND WITHOUT HER JUDICIAL APPEARANCE THE NAME CHANGE WAS GRANTED 4 DAYS LATER ON JUNE 29, 2020 (EXHIBIT 'L'). UNDER COVER OF CORRESPONDENCE DATED JUNE 30, 2020 FROM CINDY MARSHALL (THE SAME PARTY AUTHORIZING THE CORRESPONDENCE TO PETITIONER ON OCTOBER 08, 2020 AS CONTAINED AT EXHIBIT 'F') MS. HARRIS-BANKS WAS NOTICED OF THE COMPLETION OF THE CASE AND ITS CLOSURE (EXHIBIT 'M'). FROM INITIATION THROUGH CONFIRMATION OF THE NAME CHANGE PROCEEDINGS MS. HARRIS-BANKS RESIDED AT HIGH DESERT STATE PRISON AND RECEIVED THE COURT'S NOTICE THERE ALSO (EXHIBITS 'I' THRU 'M'). HER NAME CHANGE PETITION ALSO ENLISTED HER HISTORIC FELONY CONVICTIONS. ID.
