MOTION FOR EXTENSION OF TIME TO PREPARE AND FILE TRANSCRIPTS

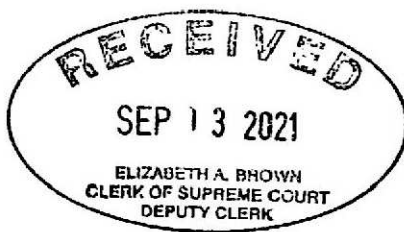
