## AMENDED EX PARTE MOTION REQUESTING THE SUPREME COURT TO DIRECT THE DISTRICT COURT TO TRANSMIT ORIGINAL EXHIBITS AND CHILD CUSTODY EVALUATION PURSUANT TO NRAP 30(d)

Appellant, DAVID STUCKE respectfully submits this amended ex parte motion and moves this Honorable Court for an order directing the District Court Clerk to transmit the original exhibits admitted during the non-jury trial in case number D-18-580621-D, as well as the confidential Child Custody Evaluation performed by John Paglini, Psy.D. and submitted to the District Court on July 23, 2020.
