Respondent in Docket No. 82414, Amber Korpak, who is also Respondent in Docket No. 82693 and Docket No. 82724, requests that Docket Nos. 82414, 82693, and 82724 be consolidated for all purposes if the Court grants Appellant's Motion for a second extension of time to file his Fast Track Statement.

These appeals are all related, and they arise from a single action in district court.

Docket No. 82414 was commenced with the filing of a notice of appeal from a final decision and order. The notice of appeal was filed while a motion for attorney's fees and costs and a motion for a new trial were pending in district court.

The district court entered orders on February 23, 2021, and February 25, 2021, resolving the motion for attorney's fees and costs and motion for a new trial.

These orders are themselves independently appealable. On March 23, 2021, Appellant filed a notice of appeal from the order regarding attorney's fees and costs, this appeal was docketed separately as Docket No. 82693. On March 25, 2021, Appellant filed a notice of appeal from the order regarding the motion for a new trial, this appeal was also docketed separately as Docket No. 82724.

Because all of the appeals arise from a single district court case, and the issues are inextricably intertwined, it would make sense to combine these appeals for all appellate purposes.

Therefore, respondent suggests for purposes of judicial economy that these three matters should be consolidated for all appellate purposes. Respondent requests that an amended briefing order be entered allowing the parties to file one set of briefs, rather than requiring duplicative, parallel briefing.
