MOTION FOR EXTENSION OF TIME TO FILE ANSWERING BRIEF AND MOTION FOR LEAVE TO REQUEST EXTENSION AFTER THE DEADLINE

Respondent requests an extension of 30 days, through November 15, 2021, to file its answering brief. NRAP 31(b)(3)(C); NRAP 26(b)(1)(A). This is the first such motion. The brief was due on October 15, 2021. No requests for extension of time have been denied or denied in part.

Undersigned counsel entered their appearance recently. The additional time will enable counsel to familiarize themselves thoroughly with the issues, the record, and relevant authorities. The extension also will allow respondent to address points and authorities the Nevada Justice Association may raise in its amicus brief, which is due on November 10, 2021.

Appellant also seeks leave to make this request to extend the 1

deadline for the answering brief out of time and to have the extension applied retroactively. See NRAP 26(b)(1)(A) ("For good cause, the court may extend the time prescribed by these Rules or by its order to perform any act, or may permit an act to be done after that time expires.") The extension was not sought before the October 15 deadline due to a lapse in communication stemming from the early paternity leave of the attorney coordinating Lewis Roca's retention. When Abraham Smith's wife suffered complications in her pregnancy, he was required to take family leave much sooner than anticipated. Although the failure to file the motion on time certainly was not his fault, the deadline was missed in the shuffle. Meanwhile, trial counsel at Hall Prangle & Schoonveld reasonably expected that Lewis Roca would procure the extension. Respondent appreciates the Court's indulgence.
