# UNOPPOSED MOTION FOR EXTENSION OF TIME TO FILE ANSWERING BRIEF

Respondent requests an extension of 30 days, through January 14, 2022, to file its answering brief. NRAP 31(b)(3)(C). This is the third such motion requesting an extension of the original October 15, 2021, deadline. Without this extension, the brief would be due December 15, 2021. No requests for extension have been denied or denied in part.

Counsel for appellants communicated that they do not oppose this extension. Their professional courtesy is greatly appreciated.

Extraordinary circumstances and extreme need necessitate this request. The brief is nearly complete. Undersigned counsel, however, has had to take significant time away from this matter to deal with medical issues involving his newborn son. In addition, the attorneys who ordinarily

would have worked on this brief have been under extraordinary pressures dealing with a trial, which unexpectedly continued past the Thanksgiving holiday; the jury just returned its final verdict last week. This has added to an already-existing backlog. Respondent's lead appellate counsel also had to take time preparing for an oral argument before this Court on December 7, 2021.

Finally, respondent notes that this Court recently published a decision interpreting NRS 41A.071, and the extension would enable undersigned counsel to determine whether this decision affects any of the arguments in the brief.

In the wake of these unexpected developments, counsel have engaged the services of a Nevada-licensed attorney in another office to expeditiously work on finalizing a draft of the answering brief. Counsel will work diligently in an effort to move this case forward.

Counsel appreciates this opposing counsel's and this Court's courtesy in considering the requested extension.
