

Mr. Marcello addressed the Motion to dismiss; and argued as investigation from 2009, there being no standardized or sufficient procedure in place as to when law enforcement turns investigation or Brady information over to the State, there being no assurance for defense to know if Brady material was turned over, and there being no recourse for defense. Mr. Palal argued interviews were done in 2016, everything from 2009 is basis of the investigation, the State went through Officer Cook's binder, the State did not review the 2009 investigation further until the scheduled meeting, the State wanted to make sure the whole file was turned over for State to review, Mr. Fumo had asked whether there was more information, the State had turned over information from two years prior to defense, the State also turned over additional information to defense just in case defense did not have it, the alleged sand bagging by State claim being made by defense counsel is nonsense, there is no extraordinary discovery issue, and Mr. Marcello was not the person the State was dealing with on this case either. Mr. Palal added two statements were turned over. Mr. Marcello confirmed that was correct; and stated he may have exaggerated the issue earlier during his arguments, however, there are files and discovery the State has, and the issue is systematic where someone has multiple files, there is no way for defense to ensure it can go in one file, there is no clear chain on how it makes it over to the State, as the file from 2009 is different from the file from 2016, and there is no procedure in place to ensure the Brady discovery is being turned over timely. COURT ORDERED, Motion to dismiss DENIED.

Mr. Palal stated he will let the Court know by tomorrow whether there will be a written opposition filed by State on Deft's remaining portion of the motion to dismiss. Discussions as to 2009 proceedings and Deft's custody status on another case. Deft. made statements to Court. Court stated it will not grant the motion for release or reasonable bail today; and it will address bail on Thursday, December 13, 2018, as there is not enough information before the Court, and the State may need to supplement.
