### I. District Court entered Outstanding Orders.

NuVeda, LLC, as Petitioner, filed its Writ Petition on or about April 14, 2021. See Dkt. 21-10775. The Writ Petition was supported by an Appendix (Volumes I-VI). See Dkt. 21-10778 through Dkt. 21-10783. This Court ordered NuVeda to supplement its Writ Petition and Appendix. See Dkt. 21-13663. NuVeda supplemented its Writ Petition (Dkt. 21-16547) and Appendix (Dkt. 21-16548 through Dkt. 21-16555 and Dkt. 21-16558). In its supplement, NuVeda noted in Footnotes 3 and 5 that the district court still had not entered orders as described therein. See Dkt. 21-16547, pgs. 4-5.
