Pursuant to NRCP 12, Defendants had until February 15, 2021, to file a response to the Complaint. Defendants then filed a timely motion for an extension of time to file an answer or other responsive document.

Courts may extend a deadline to file an answer if the Defendant demonstrates good cause. NRCP 6(b)(1)(B)(i). Here, the Court finds good cause exists based upon counsel's
