COME NOW the Appellants, Fore Stars, Ltd., 180 Land Co. and Seventy
Acres, by and through their counsel, Lisa A. Rasmussen, Esq., and hereby move
this Court for an Order consolidating this case into the appeal pending in docket

1 number 82338. Appeal 82338 involves all of the same parties appearing in this
2 case and it is an appeal of the district court's granting of appellees' special motion
3 to dismiss pursuant to Nevada's anti-SLAPP statute. This appeal is an appeal of
4 the district court's award of approximately \$363,000 in attorney's fees related to
5 the issues that will be presented in the appeal in case 82338. To spare the parties
6 from briefing two separate appeals, it is in the interest of justice to consolidate
7 these appeals.

9 Further, Appellants would request that the briefing schedule for this appeal
10 be maintained for the consolidated briefing, which is set for the opening brief to
11 be filed by September 21, 2021.

13 A motion to consolidate appeals may be properly made pursuant to NRAP
14 27 and this Motion complies with the requirements of Rule 27.

15 Accordingly, it is respectfully requested that this Court enter an order
16 consolidating this case into docket number 82338 with and that the court reset the
17 consolidated briefing deadline consistent with the deadline set for this case, with
18 the opening brief due on or before September 21, 2021.
