**MOTION & STIPULATION TO
STAY APPEALS PENDING
SETTLEMENT**

Appellant, Estate of Jack P. Slovak, by and through its Executor Lynn Slovak, and Respondent, Juanita Slovak (collectively referred to as the "Parties") hereby move this Court for an Order Staying the Appeals in Cases 82631 and 82897 pending settlement. In support of their request for a stay of proceedings, the Parties have stipulated as follows:

On May 14, 2021, the Parties held a settlement conference and have agreed to settlement terms in the underlying District Court Case and the matters pending before this Court. The Parties are in the process of confirming the settlement agreement before the District Court. The requested and stipulated stay will allow the Parties, who have substantively reached and agreed upon settlement terms, to complete the settlement process via the preparation and execution of final settlement documents. The settlement reached has multiple moving parts and will require certain acts to be performed by the Parties outside of the United States. The settlement is being submitted to the District Court for ratification. Once the District Court ratifies
