1 Further, pursuant to NRAP 3E(c)(2)(E) Relevant portions of the trial or hearing that were
2 audio recorded or video recorded shall be submitted in typewritten form. The court will not accept
3 audio or videotapes in lieu of transcripts.”

5 The only issue on appeal presently is that the District Court considered best interests of the
6 child factors, which were over one and a half years old when makings its findings. The dated best
7 interest of the child analysis was res judicata at the time of the subsequent hearing. This was
8 illustrated by the District Court’s oral ruling and further confirmed by the District Court’s written
9 Order. This issue only came up sparsely in the September 15, 2020 hearing and Appellant order
10 the transcripts that were relevant to this single issue on appeal.

12 Appellant has followed NRAP 3E and has only ordered the portion of the transcript that he
13 believes is relevant and in good faith is needed to determine the appellate issues. WHEREFORE
14 Appellant, Anthony Jacob Monahan hereby respectfully requests that this Court deny the
15 Respondent’s Motion to Require Appellant to Provide Transcript of Proceedings and for all other
16 relief deemed appropriate by this Court.
