MEMORANDUM

Appellant the Las Vegas Review-Journal ("Review-Journal"), by and though its undersigned counsel of record, hereby moves this Court pursuant to Nevada Rule of Appellate Procedure 31(b) for a 14-day extension of time to file its Reply Brief.

The Review-Journal's Reply Brief was originally due November 29, 2021. The Court granted the Review-Journal's first this request for a forty-five (45) day extension, making the Review-Journal's Reply Brief currently due on January 13, 2022.

This Court cautioned in its order that, pursuant to NRAP 31(b)(3)(B), no further extensions shall be permitted absent extraordinary circumstances and extreme need. Here, there are extraordinary circumstances and extreme need to extend the deadline from January 13, 2022 to January 27, 2022:

(14) days for the Reply Brief, which would move that deadline from January 13,

2022, to January 27, 2022.
