## **POINTS AND AUTHORITIES**

Nevada Rules of Appellate Procedure 9 provides that counsel shall file a Transcript request form with the District Court and the Supreme Court. This form must contain the “(i) Name of the judge or officer who heard the proceedings; (ii) Date or dates of the trial or hearing to be transcribed; individual dates must be specified, a range of dates is not acceptable; (iii) Portions of the transcript requested; specify the type of proceedings (e.g., suppression hearing, trial, closing argument);(iv) Number of copies required; and (v) A certification by appellant’s counsel that the attorney has ordered the required transcripts and has paid the required deposits.” This certification shall specify from whom the transcript was ordered, the date the transcript was ordered, and the date the deposit was paid.

Here, counsel has requested one copy of the original transcripts from specific a specific Writ of Habeas Corpus Hearing date. I hereby further certify that I ordered the transcripts listed above from the court reporters named within the Transcript Request pursuant to NRAP 9 (a) (C).



2 Nevada Rules of Appellate Procedure Rule 9 (a) imputes a duty upon counsel to file the  
3 instant transcript request. This form must contain:

4 the “(i) Name of the judge or officer who heard the proceedings; (ii) Date  
5 or dates of the trial or hearing to be transcribed; individual dates must be  
6 specified, a range of dates is not acceptable; (iii) Portions of the transcript  
7 requested; specify the type of proceedings (e.g., suppression hearing, trial,  
8 closing argument);(iv) Number of copies required; and (v) A certification  
9 by appellant’s counsel that the attorney has ordered the required transcripts  
10 and has paid the required deposits.”

11 Here, Counsel represents Darion in the above-referenced matter, and in an accompanying  
12 appeal in Nevada Supreme Court (“NSC”) Case No. 82915. Darion is appealing this conviction with
