I, TALEEN PANDUKHT, am a duly licensed attorney in the State of Nevada and am employed by the Clark County District Attorney's Office. I am the supervising attorney in the above-captioned case. Respondent's Answering Brief is currently due January 6, 2022. The State requests a thirty-day (30) extension of time in which to file its Answering Brief.
