## **LEGAL ARGUMENT**

Nevada Rules of Appellate Procedure Rule 26 (b)(1)(B) allows this Court discretion to enlarge the time to perform any act, including filing of a Petition for Review, based upon “extraordinary and compelling circumstances.” A Petition for Review by the Nevada Supreme Court is currently due on September 20, 2022.

Counsel requests two (2) additional days to allow for completion of the aforementioned Petition, which is presently nearly complete. Since the issuance of the Court of Appeal’s Order of Affirmance on August 18, 2022, undersigned counsel has completed a jury trial for a life sentence matter and had a period of one week out of the jurisdiction for a previously scheduled trip. This, combined with the criminal calendar that includes both private and appointed criminal cases (as well as counsel’s family law practice) precluded the time necessary to timely complete the Petition during this interim thirty-three (33) days. However, only two additional days are needed prior to filing, should this Court be inclined to grant the instant request. This is the second request for an extension of time for this Petition. As a result, extraordinary and compelling circumstances exist to grant two additional days to properly file and serve a Petition for Review by the Nevada Supreme Court.
