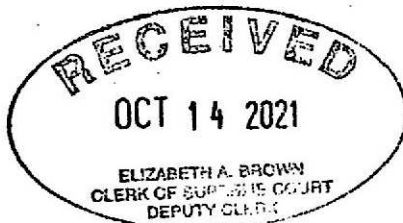

ARGUMENT

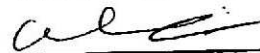
ON SEPTEMBER 29, 2021 THIS COURT TRANSFERRED
