Additionally, respondent Steven Barket filed a limited joinder to appellants' opening brief on October 1, 2021. The Hirji respondents have filed a motion to strike the joinder. Appellants have filed a limited opposition to the motion to strike, and take no position as to the arguments for or against Barket's joinder. Barket has filed an opposition to the motion to strike, and the Hirji respondents have filed a reply.

Because Barket is not an appellant in this appeal, he may not join appellants' opening brief. Accordingly, the joinder is disapproved and the motion to strike it is granted.
