- A. The **Juvenile Court** has jurisdiction over parents, step-parents, and guardians, as is incidental to its jurisdiction over children (NRS 62B.350).
- B. If a child is alleged to be delinquent or in need of supervision, the **Juvenile Court** shall advise the child and the child's parents or guardian that the child and the parent or guardian may each be represented by an attorney at all stages of the proceedings (NRS 62D.030, NRS 62D.100).
- C. **Upon adjudication in the Juvenile Court**, the Court can require the child and/or parents or guardians:
- a. To pay r estitution to the victim(s) for the child's delinquent acts (NRS 62E.550 et. seq.);
  - b. To perform co mmunity service (NRS 62E.180 et. seq.);
  - c. To pay costs of the Juvenile Court proceedings, including but not limited to reasonable attorney's fees, court costs, and other costs associated with investigating the acts committed by the child and with taking the child into custody (62E.300);
  - d. To pay fi nes, penalties and assessments imposed for delinquent acts, minor traffic offenses or for children in need of supervision (NRS 62E.270);
  - e. To pay f or liability insurance if the child and/or parents/guardians are ordered to perform community service (NRS 62E.180).

Please refer to Nevada Revised Statutes Chapter 5, Juvenile Justice for laws applicable in **Juvenile Court**.

**In civil actions**, except as otherwise provided in NRS 424.085, any act of willful misconduct of a minor resulting in injury or death to another person, or injury to the private property of another, or to public property, may be imputed to the parents or guardian having custody and control of the child for all purposes of civil damages. The persons having custody are jointly and severally liable with the minor for all damages, not to exceed \$10,000 for any such act of willful misconduct of the minor. This is in addition to any other liability imposed by law (NRS 41.470).

## INITIAL REPORT NARRATIVE

On 5/6/08 at approximately 1835 hours, I responded to an abandoned house at 527 Morse Lane, on a report of juveniles breaking bottles. Upon arrival I observed (2) juvenile males, later identified as Devon Hockemier and Cameron Riley, at the residence.

As I approached the residence, Devon and Cameron looked straight at me, turned, and ran into an empty field east of the property. I yelled at Devon and Cameron to stop. Devon and Cameron looked back at me several times but continued to run. I followed Devon and Cameron on foot and yelled at them several times to stop. Devon and Cameron ran thru the yard of a residence in the 400 block of Bullion Road, crossed Bullion Road and ran towards the River.

As I was following Devon and Cameron, I observed Cameron stop several times and act as if he wanted to give up and quit running. Devon would then persuade Cameron to keep running.

Corporal Pepper drove up behind Devon and Cameron as they continued thru the open field toward the river. Corporal Pepper ordered Devon and Cameron to stop running. Cameron stopped running but Devon continued to run. Corporal Pepper detained Cameron for obstructing. I lost sight of Devon as he disappeared over the river bank.

I searched the area for Devon but was unable to locate him. Cameron directed Corporal Pepper and I to Devon's residence at 651 Bullion Road #57. I located Devon inside his residence and detained him for obstructing. I transported Devon to Juvenile Detention for booking. Corporal Pepper transported Cameron to his residence and released him to his mother.

This report is being submitted to Juvenile Probation for prosecution review.



**RECOMMENDATION**

At the hearing, all interested persons were given an opportunity to be heard. Good cause appearing, the Court recommends the following disposition and Orders:

**DRIVER'S LICENSE SUSPENSION (IMMEDIATE):** The child's driver's license and/or instructional permit is hereby suspended for 30 days until August 29, 2008 pursuant to NRS 62E.430(1)(b)(2).

**FINE & ADMINISTRATIVE ASSESSMENT:** Pay a fine of \$100.00 for COUNT 1, plus a \$10.00 assessment (NRS 62E.270), for a total of \$110.00 to be paid on or before August 29, 2008 to the Elko County Juvenile Probation Department.

**COOPERATION OF PARENTS:** The parents(s), step-parents(s) and/or guardian(s) of the juvenile are ordered to cooperate and assist the juvenile in the completion of the sanctions outlined in the order of disposition. This includes, but is not limited to, facilitating transportation on behalf of the juvenile to all required classes, appointments, community service, counseling, drug testing and/or juvenile detention time. Any person who willfully violates, neglects or refuses to obey the terms of any order of disposition made by the juvenile court is guilty of a misdemeanor. 



**Notice to Parents/Guardians**

- A. The **Juvenile Court** has jurisdiction over parents, step-parents, and guardians, as is incidental to its jurisdiction over children (NRS 62B.350).
- B. If a child is alleged to be delinquent or in need of supervision, the **Juvenile Court** shall advise the child and the child's parents or guardian that the child and the parent or guardian may each be represented by an attorney at all stages of the proceedings (NRS 62D.030, NRS 62D.100).
- C. **Upon adjudication in the Juvenile Court**, the Court can require the child and/or parents or guardians:
  - a. To pay restitution to the victim(s) for the child's delinquent acts (NRS 62E.550 et. seq.);
  - b. To perform community service (NRS 62E.180 et. seq.);
  - c. To pay costs of the Juvenile Court proceedings, including but not limited to reasonable attorney's fees, court costs, and other costs associated with investigating the acts committed by the child and with taking the child into custody (62E.300);
