





ORDER GRANTING IN PART PLAINTIFFS' MOTION FOR ATTORNEYS' FEES, COSTS, AND **INTEREST** AND GRANTING IN PART **DEFENDANTS' MOTION TO RETAX** COSTS

This matter being decided in chambers, on plaintiffs First 100, LLC and 1st One Hundred Holdings, LLC's ("Plaintiffs") motion for attorneys' fees, costs, and interest, and defendants Joel Just and Eagle Rock Asset Management, LLC's ("Defendants") motion to retax costs. The Court having considered the pleadings, papers, and documents on file therein and being otherwise fully advised, and good cause appearing therefore:

FINDINGS OF FACT

- 1. This matter went to a bench trial which took place from January 28, 2020 through January 30, 2020.
- 2. Following the bench trial, the Court issued its Findings of Fact, Conclusions of Law, and Judgment, filed on April 22, 2020, which are incorporated herein by reference.
- 3. The Court reiterates its original finding that pursuant to Sections 13.9 and 13.10 of the 1st One Hundred Operating Agreement (Trial Exhibit 1), attorneys' fees and costs are to be awarded, and additionally finds herein that the contractual provisions relied upon by Plaintiffs contemplate an award of attorneys' fees to the prevailing party which are not rendered nugatory by the arbitration provision, because it was determined in this action that the Court could properly serve as the forum for resolution of the subject disputes between the parties involved up to and including trial.
- 4. The Court finds that NRS 18.010(2)(b) is not a basis in this case for an award of attorneys' fees to the Plaintiffs.
- 5. The Court finds that some of the work performed in this case is not attributable to issues between the parties relating to the causes of action that actually went to trial. Therefore, the Court finds that even if the attorneys' fees incurred by Plaintiffs are reasonable from the standpoint of what is owed to Plaintiffs, the totality of the fees is not properly payable by Defendants, and the amount should be reduced to reflect the work performed in this case attributable to the issues between the parties involved in the case as it was litigated and went to trial.
- 6. The Court finds that defendant Eagle Rock Asset Management, LLC was not a party to the contract on which the Court is basis its attorneys' fees, award, therefore, the attorneys' fees award will only be against defendant Joel Just.
- 7. The Court finds that the Plaintiffs' attorneys' fees are reasonable pursuant to *Brunzell* v. Golden Gate National Bank, 95 Nev. 345, 349 (1969) to justify an award of \$100,000.00 against defendant Joel Just.
- 8. The Court also finds that following entry of the original post-trial Findings of Fact, Conclusions of Law, and Judgment, the Plaintiffs timely filed a Verified Memorandum of Costs and Disbursements on April 29, 2020.

- 9. The Court finds that the Defendants timely filed a Motion to Retax within three days after service of the Memorandum of Costs and Disbursements, as is required pursuant to NRS 18.110(4) and *Sheehan & Sheehan v. Nelson Malley & Co.*, 121 Nev. 481, 493, 117 P.3d 219, 227 (2005).
- 10. The Court finds that Plaintiffs filed subsequent briefing acknowledging that they reduced their claimed costs by \$7,500.00 for the injunction security which has been returned, along with reducing the claimed costs as a result of an error regarding Kregg Hale's deposition costs, which left Plaintiffs' claimed costs at \$25,278.15.
- 11. The Court finds that the costs claimed for the arbitration in the sum of \$11,700.00 are not taxable.
- 12. The Court finds that the remaining costs, constituting \$13,578.15, are permissible costs pursuant to NRS 18.005 and therefore taxable, with interest to accrue from entry of judgment.

CONCLUSIONS OF LAW

- 13. In Nevada, an award of attorneys' fees is permitted whenever authorized by statute, contract or rule. *Frank Settelmeyer & Sons, Inc. v. Smith & Harmer, Ltd.*, 124 Nev. 1206, 1220, 197 P.3d 1051, 1060 (2008).
- 14. Here, there can be no dispute that the Plaintiffs are the prevailing party in this litigation. As set forth in *Hornwood v. Smith's Food King*, 105 Nev. 188, 192 (1989), a "plaintiff may be considered the prevailing party for attorney's fees purposes if it succeeds in litigation which achieves some of the benefits sought in bringing suit." Thus, because Plaintiffs succeeded in obtaining a \$420,000.00 judgment following the bench trial (*See* 4/22/2020 Findings of Fact, Conclusions of Law, and Judgment, *on file*), Plaintiffs are the prevailing party in this litigation.
- 15. Pursuant to the 1st One Hundred Operating Agreement and the factors set forth in *Brunzell v. Golden Gate Nat'l Bank*, Plaintiffs are entitled to the fees they incurred in the amount of \$100,000.00.
- 16. The Nevada Supreme Court requires the consideration of four factors for every award of attorney fees: (1) the qualities of the advocate: his ability, his training, education, experience, professional standing and skill; (2) the character of the work to be done: its difficulty, its intricacy, its

importance, time and skill required, the responsibility imposed and the prominence and character of the parties where they affect the importance of the litigation; (3) the work actually performed by the lawyer: the skill, time and attention given to the work; (4) the result: whether the attorney was successful and what benefits were derived. *See Brunzell v. Golden Gate National Bank*, 95 Nev. 345, 349 (1969).

- 17. Because consideration of all four factors establishes that the Plaintiffs' the portion of Plaintiffs' request for fees that relates to the causes of action between Plaintiffs and Defendants that actually went to trial is reasonable, this Court awards the Plaintiffs' attorneys' fees in the amount of \$100,000.00.
- 18. With respect to the first *Brunzell* factor, the "training, education, experience, professional standing and skill" of the attorneys' involved, the quality of MAIER GUTIERREZ & ASSOCIATES has been established in Plaintiffs' motion for fees. Prior to opening MAIER GUTIERREZ & ASSOCIATES, the firm's partners previously worked for law firms such as GREENBERG TRAURIG and BECKLEY SINGLETON, among others. These firms are well known in the Las Vegas legal community with a reputation for experienced and professional attorneys. The Court concludes that the hourly rate increases over time for each of Plaintiffs' counsel were reasonable and properly adjusted at appropriate intervals to reflect the going rates for professional attorneys in the Nevada community handling these types of matters with similar experience, skill, and credentials, including Joseph A. Gutierrez, Esq.'s hourly rate which began at \$295 per hour and ended at \$495 per hour, and Danielle J. Barraza, Esq.'s hourly rate which began at \$195 per hour and ended at \$395 per hour. The Court concludes that these hourly rates, along with those of other counsel and staff at Maier Gutierrez & Associates who worked on the matter on behalf of Plaintiffs, were reasonable.
- 19. With respect to the second *Brunzell* factor, the "difficulty, intricacy, and importance of the work involved," this was a complex business matter involving 16 claims asserted against defendant Just, 7 claims asserted against defendant Eagle Rock Asset Management, LLC, and 3 counterclaims against plaintiff First 100. Preparation for the bench trial required considerable time, skill, and effort. Plaintiffs had to engage in significant discovery and motion practice in order to prove their claims against defendants Just and Eagle Rock Asset Management, LLC. Plaintiffs' counsel's

understanding of the various issues that were needed to succeed on the claims at trial with a significant damages award supports the conclusion that the attorneys' fees were earned and are fair and reasonable.

- 20. With respect to the third *Brunzell* factor, "counsel's skill, time, and attention" given to the work was commensurate with the work required to take a case through an a bench trial. The preparation was thorough and complete, and the Court has reviewed and observed the extensive level of work required as set forth in Plaintiffs' motion for fees. Considering the amount of time and effort exerted by the Plaintiffs' counsel, the fees are clearly substantiated.
- 21. With respect to the fourth *Brunzell* factor, the result, the Plaintiffs were ultimately successful, as the Court awarded Plaintiffs a judgment in the amount of \$420,000.00, and dismissed defendant Just's counterclaims.
- 22. However, the Court concludes that defendant Eagle Rock Asset Management, LLC was not a party to the contract on which the Court is basing its attorneys' fees award, and therefore, the attorneys' fees award will only be against defendant Joel Just.
- 23. Accordingly, the Court concludes that \$100,000.00 in attorneys' fees is reasonable as it relates to the work that Plaintiffs' counsel put into taking the claims at issue between the parties to trial, and awards \$100,000.00 in reasonable fees to Plaintiffs and against defendant Joel Just only.
- 24. The Court concludes that no portion of the \$100,000.00 attorneys' fees award relates to any sum against defendant Eagle Rock Asset Management, LLC.
- 25. The Court concludes that an award of costs is appropriate pursuant to NRS 18.005 and NRS 18.020, as the Plaintiffs are the prevailing party.
- 26. The Court concludes that Plaintiffs timely filed a Verified Memorandum of Costs and Disbursements on April 29, 2020.
- 27. The Court concludes that Defendants timely filed a Motion to Retax within three days after service of the Memorandum of Costs and Disbursements, as is required pursuant to NRS 18.110(4) and *Sheehan & Sheehan v. Nelson Malley & Co.*, 121 Nev. 481, 493, 117 P.3d 219, 227 (2005).

28. The Court concludes that Plaintiffs filed subsequent briefing acknowledging that they

reduced their claimed costs by the \$7,500.00 for the injunction security which has been returned, along with reducing the claimed costs as a result of an error regarding Kregg Hale's deposition costs, which left Plaintiffs' claimed costs at \$25,278.15.

- 29. The Court concludes that the costs claimed for the arbitration in the sum of \$11,700.00 are not taxable.
- 30. The Court concludes that the remaining costs, constituting \$13,578.15, are permissible costs pursuant to NRS 18.005 and therefore taxable, with interest to accrue from entry of judgment.
- 31. Therefore, the Court concludes that the Plaintiffs are awarded costs in the amount of \$13,578.15.

ORDER

32. IT IS HEREBY ORDERED, ADJUDGED AND DECREED that the Plaintiffs' motion for fees, costs, and interest is GRANTED in part and DENIED in part, with Plaintiffs being awarded fees in the amount of \$100,000.00, as an award against defendant Joel Just only, not defendant Eagle Rock Asset Management, LLC.

This correspondence is in relation to TGC/Farkas Funding, LLC ("TGC") Membership Interest in in 1st One Hundred Holdings, LLC (the "Company"), and certain of its obligations thereunder.

As you are aware, on or about April 2017, the Company made an offering of Membership Interest Redemption to its ownership. All non-executive members, including TGC, executed the Membership Redemption Agreement.

On or about September 2020, it was adjudicated in arbitration that Matthew Farkas, the Manager and 50% owner of TGC exceeded his authority in exercising the Redemption Agreement on behalf of his company, and the Redemption Agreement was deemed to be voided, which decision was confirmed by the District Court on or about October 2020.

Pursuant to the Company's Operating Agreement, and voiding of the TGC Redemption Agreement, TGC is the only remaining non-executive owner of Membership Interest, originally a 3% Membership Interest, later increased to 4.553% Membership Interest after all non-executive

Redemptions of Membership Interest (see attached Schedule of Membership Interest) in 1st One Hundred Holdings, LLC.

Further, paragraphs 7.5 and 7.13 of the Operating Agreement provides for indemnification as follows:

- 7.5 EXTENT OF INDEMNIFICATION. A Person shall be indemnified under this Article against judgments, penaltics (including excise and similar taxes), fines, sattlements, and reasonable expenses actually incurred by the Person in connection with the proceeding; but if the Person is found liable to the Company or is found liable on the basis that Personal benefit was improperly received by the Person, the indemnification shall (a) be limited to reasonable expenses actually incurred, and (b) not be made in respect of any proceeding in which the Person shall have been found liable for willful or intentional misconduct in the performance of such Person's duty to the Company.
- 7.13 INDEMNIFICATION OF OFFICERS. The Company may, at the discretion of the Manager, indemnify and advance or reimburse expenses to a Person who is or was an officer of the Company to the same extent that it shall indemnify and advance or reimburse expenses to Manager under this Article.

Accordingly, the Manager and all Executive Members are indemnified by the Company, leaving TGC as the only remaining non-indemnified Member of the Company subject to a capital call for Indemnified matters, such as the instant matters causing the Subsequent Capital Call.

As you are aware, as a result of a recent action brought by TGC, first in Arbitration and later in the Nevada State Courts, and the resultant decisions, the Company is now in need of capital contributions, and as such, does hereby put forth a capital call to its membership for the following Expenditures anticipated:

Further, the actions of TGC and resultant findings have had a material adverse impact on the negotiations related to the sale of the Company's sole asset, the judgment.

Additionally, it is anticipated that additional Capital Calls will be made in the future to fund the Company's ongoing additional expenses in the event the sale of the Judgement cannot be recovered.

Capital Contributions are to be wired no later than by 5pm EST on Friday, April 16, 2021, with proof of transfer provided to the Manager on or before such deadline.

Pursuant to the Company Operating Agreement, Section 4.3, the consequences for TGC's failure to fund its obligations are as follows:

- 4.3 FAILURE TO CONTRIBUTE. If a Member does not contribute all of its share of a Capital Call by the time required, then either:
 - One or more Class A Members may provide the additional capital, with such added capital to be reflected in that Class A Member's Capital Contribution, however, such additional capital to be entitled to priority return superior to those set forth in Article V.

- 2) Any other Members, individually or in concert (the "Lending Member," whether one or more), to advance the portion of the Delinquent Member's Capital Call that is in default, with the following results:
