10                   **APPELLANTS MOTION TO EXTEND TIME TO FILE TRANSCRIPT REQUEST**

11                   Pursuant to NRAP 26(b) (1) (A) and NRAP 27 and prior orders of this  
12 Court, Appellants move for an extension of time to file transcript  
13 request in accordance with the facts, points and authorities cited  
14 herein.  
15

16                   **I. STATEMENT OF THE ISSUE.**

17                   Appellants request an extension of time to file the transcript  
18 request in this Court to January 13, 2022 in accordance with the prior  
19 order of this Court to file and serve the Appellants' Transcript  
20 Request Form, 14 days from the date of the order, September 30, 2021.  
21

22                   **II. FACTS.**

23                   Counsel for Appellants had just had cancer surgery and was  
24 recovering. On the date that the transcript request was due, Counsel  
25 filed the request for the transcripts with the appropriate court  
26 reporters for the District Court departments in which the various  
27 hearings were held. Transcripts were ordered timely, pursuant to NRAP  
28 9(a) (3), Appellants ordered the transcripts pursuant to the district

1 court transcript order form prescribed for use by Department XIV, were  
2 paid for and have been filed in the Register of Actions in the  
3 underlying District Court case, case numbered A-19-792836-C.

4 However, due to his recovery from surgery in which he had received  
5 general anesthesia to have his cancer removed, he was still groggy and  
6 feeling poorly. The Request for Transcript was not filed with the  
7 Supreme Court.

8  
9 In order to properly advise this Court going forward that the  
10 transcripts were filed for properly, Counsel requests approval to file  
11 the attached transcript request form as soon as is possible, along with  
12 the invoice provided showing the transcripts were filed upon payment by  
13 Appellants.

14 Appellants have not made a prior request for an extension to file  
15 this request. Appellants previously complied with the order to request  
16 the transcripts on or before October 14, 2021 however, through  
17 excusable neglect, due to illness and surgery, failed to file the  
18 document with this Court.

19  
20 **DECLARATION OF ANDREW WASIELEWSKI IN SUPPORT OF MOTION FOR EXTENSION**

21 ANDREW WASIELEWSKI, declares, pursuant to NRS § 53.045, under  
22 penalty of perjury, that the following is true and correct:

23 1. I am over the age of 18 years and have personal knowledge of  
24 the facts stated herein, except for those stated upon information and  
25 belief, and as to those, I believe them to be true.

26  
27 2. I am the Counsel for the Defendants Margaret Reddy, Mohan  
28 Thalamarla and Max Global herein. I have been in the practice of law

1 since 1996 and I am competent to testify as to the facts stated  
2 herein in a court of law and will so testify if called upon.

3 3. Between July and September of 2021, I developed an unusual  
4 fast growth on my hip. During the month of September of 2021, I  
5 developed pain in my hip and went into the hospital for an emergency  
6 surgery on or about September 20, 2021. Due to other medical  
7 complications, my surgery was postponed until October 7, 2021 in the  
8 State of Florida.

9  
10 4. While still very much in pain and feeling poorly, on October  
11 14, 2021, I filed the Transcript Request Form with the District  
12 Court, utilizing the form prescribed by Department XIV it approved  
13 for this purpose.

14 5. In Exhibit 1, I have attached the emails communicated  
15 between myself and the court reporters for Department XIV and the  
16 Discovery Commissioner regarding the transcripts.

17  
18 6. I later received the invoices for the transcripts prepared  
19 by those reporters. Shortly thereafter, the invoices were paid.

20 7. I attach the Register of Actions for case A-19-792836-C  
21 showing the transcripts were filed in this case.

22 8. "I declare under penalty of perjury that the foregoing is  
23 true and correct."

III. POINTS AND AUTHORITIES

A. APPELLANTS COMPLY WITH THE PROCEDURE TO REQUEST AN EXTENSION OF  
TIME TO FILE THE REQUEST FOR TRANSCRIPT

NRAP 26(b) (1) (A) states in pertinent part:

"(A) For good cause, the court may extend the time prescribed by these Rules or by its order to perform any act, or may permit an act to be done after that time expires. But the court may not extend the time to file a notice of appeal except as provided in Rule 4(c)."

The request was originally due on October 14, 2021. No extensions were previously granted to file this request. The briefing schedule was suspended for settlement purposes. Appellants and Respondent were not able to settle and Appellants filed a second appeal. That appeal is currently in the settlement program and Appellants think that settlement is possible. As Appellants filed two appeals regarding the same underlying matter, they will move in the other appeal to consolidate both appeals and to place both appeals into the settlement program currently being conducted in the second appeal, 83763.

Separately, in this appeal, Appellants will move separately to stay the filing of the opening brief until after the cases are consolidated and after the settlement program has been successful or the consolidated appeal is deemed not ripe / appropriate for settlement by the Supreme Court Settlement Judge.

No extension in this case has been denied in any form.

An extension is necessary for the following reasons:

a) Appellants would like to comply with proper procedure to show that the transcript request form was filed properly on October

1 14, 2021, with the District Court, the transcripts were made,  
2 were paid for and were filed in the underlying case.

3 b) Appellants allege that for all these reasons, the requested for  
4 extension of time is appropriate and warranted.

5 c) To further demonstrate excusable neglect, Appellants' Counsel  
6 has been out of Nevada undergoing cancer screening and cancer  
7 surgery in Florida in October of 2021 and sick during October  
8 for weeks after his surgery.  
9

10 The new date of request would be the date this request for  
11 extension is approved or as soon as January 13, 2022. Appellants have  
12 attached the form, the emails to and from both court reporters for  
13 Department XIV and the Discovery Commissioner, the invoices and the  
14 register of actions showing the transcripts were filed in Exhibit 1.

#### 16 IV. CONCLUSION

17 Therefore, as Counsel has shown good cause for why this extension  
18 is requested and the request is in compliance with NRAP 9 and NRAP 26,  
19 Appellants request approval of their motion.
