1 **MEMORANDUM OF POINTS AND AUTHORITIES**

2 I, MARTIN HART, am a duly licensed attorney in the State of Nevada and
3 am represent the appellant.

4 Appellant's Opening Brief is currently due January 24, 2022. This Court
5 may extend the time to file an Opening Brief upon a showing of good cause.
6 NRAP 31(b)(3). At the end of August 2021, I took over most of the court
7 appointed cases assigned to Dan Bunin after he tragically passed away while on
8 vacation. I did not receive his files that were available until the second week of
9 September and many did not have contact information for the clients nor legible
10 notes. I have spent countless hours getting familiar with those cases and attempting
11 to contact clients. With the change in court procedures due to covid and taking
12 over new cases I find myself in hearings most days five or more hours. The
13 majority of the transcripts in this case were filed on September 14, 2021. I
14 previously requested an extension in November which was granted. Since that time
15 I have completed two jury trials while preparing for four others that were that were
16 continued at the last moment or in one case negotiated at the time of jury selection.
17 I have not completed the briefing and am requesting an addition sixty (60) days
18 within which to file the opening brief and appendix.
