

This case was set for Jury Trial to commence on March 17, 2020. On March 13, 2020, the trial was cancelled because of COVID concerns. The trial was rescheduled for June 1, 2021, and was again vacated on May 5, 2021, when as a result of a settlement conference pursuant to NSCR 252(2), a resolution short of trial was reached. On May 5, 2021, Appellant entered an *Altford* plea to Voluntary Manslaughter, in violation of NRS 200.040, 200.050, and 200.080. Sentencing was set for July 1, 2021. Appellant appeared with counsel for sentencing on July 1, 2021. Appellant was sentenced to imprisonment in the state prison for a maximum term of one hundred twenty (120) months and a minimum term of forty-eight (48) months, a fine of ten thousand dollars (\$10,000.00), and court statutory fees and assessments totaling six hundred seventy-eight dollars (\$678.00). The Judgment of Conviction was filed on July 2, 2021. This is an appeal from the Judgment of Conviction.

- 11. This case has not previously been the subject of an appeal in the Nevada Supreme Court
- 12. This case does not involve child custody or visitation.
