MEMORANDUM/DECLARATION

Counsel, Baylie A. Hellman, on behalf of the attorney of record Damian R. Sheets, is a duly licensed attorney in the State of Nevada and have been retained to represent Appellant Hamza Zalyaul in the instant appeal.

On November 23, 2022, this Court issued its decision vacating the conviction and sentence imposed by the Eighth Judicial District Court.

On December 9, 2022, Appellant filed a Request for Expedited Remittitur.

After various other filings, on December 27, 2022, Respondent timely filed its Petition for Rehearing, which was denied on December 29, 2022.

On January 9, 2023, Respondent timely filed its Petition for En Banc Reconsideration. This Court directed Appellant to answer the Petition, and such answer was ultimately filed on February 10, 2023¹.

On March 3, 2023, this Court filed its Order Denying En Banc Reconsideration.

¹ Appellant's Answer was timely filed first on February 8, 2023. However, the filing was rejected for lack of a Certificate of Compliance. Appellant's corrected Answer was thereafter timely filed on February 10, 2023.

Upon information and belief, there are no further remedies available to Respondent under the Nevada Rules of Appellate Procedure to challenge this Court's decision.

It is undersigned counsel's understanding that the Nevada Department of Corrections, where Mr. Zalyaul is currently incarcerated, will not release Respondent until the remittitur is issued to the District Court.

Mr. Zalyaul is prejudiced each day he remains in custody as a result of the delay in issuing the remittitur; since the date of the Order Denying En Banc Reconsideration, Mr. Zalyaul has served 10 additional days on a sentence that has since been vacated.

As such, Undersigned Counsel respectfully renews Appellant's request that the remittitur issue on an expedited schedule to ensure Mr. Zalyaul's timely release.
