DECLARATION OF WILLIAM M. WATERS

1. I am an attorney licensed to practice law in the State of Nevada; I am a deputy public defender assigned to handle the appeal of this matter; I am familiar with the procedural history of this case.

2. The notice of appeal in this matter was filed with the District Court on August 5, 2021, and docketed in the Supreme Court on August 6, 2021.

3. On October 14, 2021, Court Recorder Boyd filed a Motion for Extension asking for an extension of 45 days to prepare and file the necessary transcripts.

4. On October 18, 2021, the Court filed an order granting an extension for court recorder Boyd until November 8, 2021.

5. On November 30, 2021, Appellant filed a Stipulation requesting the Opening Brief's due date be extended until January 5, 2022.

6. On December 16, 2021, the trial transcripts were filed in this matter. The trial consists of five days and over 750 pages.

7. As of today, December 29, 2021, the transcripts of June 30, 2021 and the sentencing transcript of July 30, 2021 have not been filed and/or received.

8. I am asking for an extension of thirty-three (33) days within which to receive the final transcripts, incorporate said transcripts into the Appendices and finalize the opening brief in this matter.
