MEMORANDUM OF POINTS AND AUTHORITIES

a. Facts

This is an appeal taken from the Findings of Fact and Conclusions of Law made by a hearing panel appointed by the State Bar of Nevada. The issued Notice of Briefing Schedule/Bar Discipline was filed by the Supreme Court of Nevada on August 10, 2021 and at that time the Court issued an Order that Appellant file his Opening Brief on September 9, 2021.

Appellant has had appointments at his oncologist's office in August and September 2021 and the reason for treatment has left Appellant unable to timely complete Appellant's Opening Brief as planned. Therefore, Appellant seeks this first extension of time to file the Opening Brief until October 11, 2021.

b. Law

NRAP 27 and NRAP 31(b)(3) permit a party to file a motion to seek an extension of time to file a brief. This motion satisfies the requirements of NRAP 27 and 31(b)(3).

Appellant's Opening Brief is currently due September 9, 2021. Good cause exists for Appellant to be granted a first extension of time until October 11, 2021 as set forth above.

c. Summary

Appellant respectfully requests that the Court grant this 30 day extension request and extend the time to file Appellant's Opening Brief to October 11, 2021.


