APPELLANT'S MOTION TO EXTEND TIME TO FILE OPENING BRIEF
(FOURTH REQUEST)

Appellant, Brian C. Padgett, in proper person, hereby respectfully moves this Court for a one (1) day extension of time to and including November 18, 2021 to file his Opening Brief. Appellant has previously requested that he be granted until November 17, 2021 to file his opening brief pending approval by this Court.

This Motion is made in good faith and for good cause pursuant to NRAP 27 and 31.

MEMORANDUM OF POINTS AND AUTHORITIES

a. Facts

This is an appeal taken from the Findings of Fact and Conclusions of Law made by a hearing panel appointed by the State Bar of Nevada. The issued Notice of Briefing Schedule/Bar Discipline was filed by the Supreme Court of Nevada on August 10, 2021 and at that time the Court issued an Order that Appellant file his Opening Brief on September 9, 2021.

Appellant has had appointments and treatment at his oncologist's office in August and September 2021 which necessitated the first request to extend time. These appointments and treatment have continued in October and November 2021 and now include seeing specialists in endocrinology. The reasons for treatment and underlying condition have left Appellant unable to timely complete Appellant's Opening Brief by November 10, 2021. Therefore, Appellant sought an extension of time to file his Opening Brief until November 17, 2021. This is pending approval by the Court.

As of November 17, 2021 Appellant's Opening Brief is complete but for citations to certain Appendices filed by Respondent. However, Appellant has been

unable to open certain filed Respondent Appendices in order to cite to the record and is now requesting a one (1) day extension of time until November 18, 2021 to resolve this matter, make final citations to the record and file his Opening Brief.

b. Law

NRAP 27 and NRAP 31(b)(3) permit a party to file a motion to seek an extension of time to file a brief. This motion satisfies the requirements of NRAP 27 and 31(b)(3).

Appellant's Opening Brief is currently due November 17, 2021 (pending approval by the Court). However, good cause exists for Appellant to be granted a one (1) day extension of time until November 18, 2021 to file Appellant's Opening Brief as set forth above.

c. Summary

Appellant respectfully requests that the Court grant this one (1) day extension request and extend the time to file Appellant's Opening Brief to November 18, 2021.
