MEMORANDUM OF POINTS AND AUTHORITIES

a. Facts

This is an appeal taken from the Findings of Fact and Conclusions of Law made by a hearing panel appointed by the State Bar of Nevada. The issued Notice of Briefing Schedule/Bar Discipline was filed by the Supreme Court of Nevada on August 10, 2021. Thereafter, Appellant filed his Opening Brief on November 18, 2021. Respondent filed his brief on January 19, 2022. Appellant's Reply Brief is currently due on March 23, 2022.

Appellant has had ongoing health issues which are being treated by his oncologist and have continued in the month of March 2022. The reasons for treatment and the treatment itself have left Appellant unable to timely complete Appellant's Reply Brief by March 23, 2022. Therefore, Appellant seeks this second extension of time to file his Reply Brief until March 28, 2022.

It is believed Appellant will need no further health-related extensions beyond this currently requested extension.

b. Law

NRAP 27 and NRAP 31(b)(3) permit a party to file a motion to seek an extension of time to file a brief. This motion satisfies the requirements of NRAP 27

and 31(b)(3).

Appellant's Reply Brief is currently due March 23, 2022. Good cause exists for Appellant to be granted this requested extension of time until March 28, 2022 to file Appellant's Reply Brief as set forth above.

c. Summary

Appellant respectfully requests that the Court grant this five (5) day extension request and extend the time to file Appellant's Reply Brief to March 28, 2022.
