1 **MEMORANDUM OF POINTS AND AUTHORITIES**

2 **I.**

3 **INTRODUCTION**

4 The parties to this post-Decree divorce action are Plaintiff, DEVIN REED
5 (“Devin”) and Defendant, AMANDA REED (“Amanda”). Devin and Amanda
6 have two children from their marriage, to-wit: ABIGAIL REED (“Abby”), born
7 April 6, 2013, presently age 7; and SHAWN REED (“Shawn”), born July 3, 2015,
8 age 4.
9

10 Amanda has engaged in a pattern of harassment, threats, alienation, and
11 pathogenic parenting since the Parties separated. Her actions are detrimental to the
12 welfare of the minor children and this Court must take action to stop her. Even as
13 this Supplemental Pleading was being drafted, Amanda’s behavior continues.
14 Sadly, she is so focused on tearing down Devin, she has neglected to protect the
15 children.

18 As this Court is aware, her boyfriend, Jeffery Eatherly (“Jeff”), is currently
19 incarcerated in the Clark County Detention Center on charges of Sexual Assault
20 Against Child Under 14, Lewdness W/Child Under Age 14, and Use/Permit Miner
21 Under 14 To Produce Pornography. Amanda has claimed that Jeffrey was not her
22 boyfriend, but rather a family friend who acted as a handyman. That is false.
23 Amanda has been dating Jeff for over a year. Exhibit 1 is a picture of Amanda,
24 Jeff, and Jason Debose from April, 2018. Exhibit 2 is a screenshot of a text
25 exchange between Amanda and Ivette Gutierrez showing Jeff playing with Abby

1 and Amanda's happiness at the scene. Exhibit 3 is a picture of Jeff and Amanda
2 sitting at a table at Ava's 2nd Birthday party. Ava is believed to be the child of
3 Cristal Tampke. Cristal is dating Jason Debose. Exhibit 4 is Christal Tampke's
4 Facebook profile picture showing her kissing Jason Debose, demonstrating that
5 they are a couple. Exhibit 5 is a screenshot of Jason Debose's Facebook friends,
6 showing he is connected to Christal Tampke on social media. Exhibits 6 and 7 are
7 from a Tuff N Uff event on June 29, 2019 at the Thomas & Mack Center at UNLV.
8 They show Amanda and her father with Jeff and several other people. Exhibit 6
9 clearly shows Amanda and Jeff sitting together. Exhibit 8 is a series of screenshots
10 from a video of Amanda and Jeff leaving the house together. The video is
11 available for the Court to view upon request and it will be included as part of
12 Devin's trial exhibits.

16 In addition to Amanda clearly not supervising Jeff with Abby, Amanda's
17 other choices are concerning. Christal Tampke is dating Jason Debose. Amanda
18 and Jeff spent time with them, as shown in Exhibits 1 and 3. Jason is not a safe
19 person to be around and Amanda certainly should not be allowing such a person
20 into the children's lives. Jason has an extensive criminal history dating back many
21 years. Exhibits 9 and 10 are the Register of Actions from the Eighth District Court
22 and Henderson Justice Court showing what is at least part of Jason's criminal
23 history. Amanda uses Jason as a babysitter during her custodial time. Upon
24 information and belief, Amanda and Jason also work together to sell Amanda's
25 prescription medication.
